



## Leadership Florida Cornerstone Class Sample Application

As you prepare to complete this application, please review the following information designed to help explain more about Leadership Florida and the selection process. A statewide Selection Committee reviews each application, and your application should reflect who you are.

Leadership Florida recommends working through the entire application separately before submitting the online application. The following pages outline the information that will be requested on the final online application.

Having the following items will help complete the final application:

- High-quality professional color headshot (300 dpi or greater)
- Professional bio (175 words or less)
- \$100 application fee
- Previous ten years of employment history
- Names and contact information for two references
- Résumé no longer than three pages in length

Please note that all open-ended questions are limited to 100 words for each response unless otherwise noted. All applications must be digitally submitted through the official Leadership Florida online application portal. No paper or emailed applications will be processed.

### CLASS SESSION DATES

The Cornerstone Class program has five in-person sessions throughout the calendar year from September-April. - You will be required to upload a high-quality color headshot photo (cropped to shoulders).
- You will also provide a professional bio describing yourself. The bio should be **175 words or less** and written in the third person. Please include personal information that helps define you, such as family, pets, hobbies, and interests.

Upon acceptance into the program, this information will be used to create a class directory. A sample directory page is included at the end of this file with examples of pictures and bios.
