Why did you choose the service branch you joined?

In 2006, the wars in Afghanistan and Iraq were becoming increasingly unpopular. I knew that there were American troops overseas fighting for my freedom, so I felt compelled to serve and repay the country that gave me so much. I wanted to be where the action was, so I joined the Marines because they are known as the "First to Fight." I now proudly serve in the United States Navy Reserve.

How did your service and experiences affect your personal and/or professional life?

It taught me the importance of merit and integrity. In the military, you are judged by your performance and work ethic, because those can't be faked. One either has a perfect physical fitness score or not; one can swim for one hour or not; one is able to shoot a target from 500 yards away or not; one empowers their teammates or not. 
