- 4) I do hereby release the Associations & LakePoint, their members, officers, directors, employees, sponsors, independent contractors, and agents from all liability, and do hereby waive as against the Associations, their members, officers, directors, employees, sponsors, independent contractors, and agents all recourses, proceedings, claims, and causes of action of any kind whatsoever, in respect of all personal injuries or property losses which I may suffer arising out of or connected with my preparation for, or participation in, the aforesaid Event, notwithstanding that such injuries or losses may have been caused solely or partly by the negligence of the Associations, their members, officers, directors, employees, sponsors, independent contractors, and agents;
