- 4) Author Contact Information
- 5) References (used to prepare Chapter Proposal)

3) Formatting:

- 1) Style format: APA
- 2) Font & Size: Times New Roman 12
- 3) Spacing: Single

- 1) Format: APA
- 2) Chapter Abstract: 250-300 words
- 3) Chapter Keywords: 5-7 words
- 4) Author Biography (100-150 words per author)
- 5) Chapter Length: 3000-5000 words (including short biographies, keywords, references, and figures/charts/tables)
- 6) References
