





- Main focus continues to be Birth Center Sustainability and we have added the understanding of the law
- Turquoise platform was renegotiated for the year with access for another year; to date 74 Birth Centers have purchased their data
 - New in 2025 offering a professional fees report, in addition to facility fees
- Learning Collaborative for Birth Center Sustainability
 - 10 workshops have been taught to date
 - 90 birth centers have taken the class, 132 attendees
 - New in 2025 updated format with new faculty

- Payors & Insurances with parity contracts: BCBS, Medicaid, Medicaid MCO/CCO, 1st Choice, Aetna, Christian Health Care Ministries, Health Partners, UHC, Multi Plan, First Health, and Kaiser

- Continued encouragement of state collaboration among Birth Centers (while still honoring anti-trust)

- States have come together to make AABC state chapters
- Continued research, troubleshooting, and education; why Birth Centers are NOT being paid; Code sets definitions, Taxonomy codes, Billing processes and Diagnosis Related Groups
- Developed and implemented the Power to Protect packet for Insurance Commissioners and Legislators
- Continuing to gain support from other entities (CABC, ACNM, NARM, MOD etc)
- Continued development of standards in birth center billing
- Provided testimony (and will continue to provide) to AMA in regard to deleting global obstetric codes, effective 1/1/2027
- Clarity on legal opinions for the ACA and other laws that pertain to Birth Center

Clarity on legal opinions for the ACA and other laws that pertain to Birth Centers:

- **Affordable Care Act (ACA) 2301 -** Requires state Medicaid agencies to cover freestanding birth center services and ensure separate payments to both the facility and licensed providers.
- Harkin Non-Discrimination Clause (ACA §2706(a)) Prohibits discrimination by private health plans against providers acting within the scope of their license or certification under state law.
- Social Security Act (SSA) This act indicates the federal government has recognized birth centers as valid, Medicaid-covered service sites. States' Medicaid (MCO & CCO) cannot arbitrarily deny reimbursement if the services meet federal criteria.
- No Surprises Act (2020) This act implies parity in payment methodology across settings, reinforcing that birth centers should not be reimbursed arbitrarily lower than equivalent hospital services.
- Omnibus Budget Reconciliation Act of 1985, 81 FR 27853 This act indicates Federal
 policy has long supported autonomous reimbursement for non-physician providers like
 midwives reinforcing that alternative birth settings like birth centers should receive
 equivalent reimbursement.





California State Chapter

- California has been losing birth centers rapidly over the last 5 years due to:
 - Dysfunctional licensing
 - Poor reimbursement
 - Workforce shortages
- In December 2024 TRICARE pulled facility contracts from all unlicensed birth centers nationally.
 - In CA, licensure is not required. There several barriers to licensure for birth centers in the state

California State Chapter

- In December 2024 TRICARE pulled facility contracts from all unlicensed birth centers nationally. Licensure barriers in CA:
 - 1. Building codes that mirror hospitals
 - 2. Requirements to participate in a statewide program that until recently barred CPMs from participating
 - 3. Limitation of 30 minute distance to a hospital with OB services
- DONE: In 2025 co-sponsored legislation to remove 2 and 3 above
- IN PROCESS: Negotiating with state on building regulations updates

Minnesota State Chapter

- Worked to improve reimbursement rates for birth centers in the State of Minnesota
 - Hired a lobbyist to work on legislative changes for the 2025 session.
 - Worked directly with DHS on proposed bill language for improved reimbursement.
 - Made website for MN State Chapter.
 - Meet weekly to keep momentum on our projects.
 - Time at the Capitol, visiting legislators and representatives and testifying for our bill.

Minnesota State Chapter

- Our legislation passed!
- Bill language
 - Facility services provided by a birth center shall be paid at the lower of billed charges or 100 percent of the hospital facility fee cost trended to current for an uncomplicated vaginal birth as determined using the most recent calendar year for which complete claims data is available.
 - If a recipient is transported from a birth center to a hospital prior to the
 delivery, the payment for facility services to the birth center shall be the lower
 of billed charges or 100 percent of the hospital facility fee cost trended to
 current for an uncomplicated vaginal delivery as
 determined using the most recent calendar year for which complete claims
 data is available.

Minnesota State Chapter

- Facility services provided to a newborn by a birth center shall be paid the lower of billed charges or 100 percent of the average room and board cost for a hospital stay.
- Birth center providers must be reimbursed for the full range of maternity care services within their scope of practice, regardless of place of service.

- Developed NYSBCA Position Statement: CABC Accreditation & Licensure, which upholds CABC as an expert in midwifery-led birth centers and clarifies licensure accessibility for midwiferyled birth centers in New York
- Connected with other stakeholder organizations including a newly formed Mobilize Maternal Health Coalition, led by NYSBCA President Myla Flores

Pennsylvania State Chapter

- Meeting monthly since chapter formed in 2024
- Focus continues to be increasing funding opportunities and reimbursement, especially with Medicaid
- Efforts have included:
 - Meeting with state representatives to discuss challenges to birth centers, especially low reimbursement rates
 - Submitted Right-to-Know request to better understand Medicaid's capitated payment rates. Information will support negotiations with MCOs towards payment equity.







Responding to A Birth Center Client's Unintended Home Birth

A phone call that can raise the blood pressure of any birth center staff member is from the family of a client at term and planning a birth center birth saying, "the baby is coming." The ideal response is for a midwife or birth assistant take over the phone call, but what if no clinical staff member is in-house? Steps can be taken to help prepare staff and families for this unexpected situation.

Early Labor Triage

Another important factor is how staff and providers respond to client phone calls about labor. A P&P addressing this issue can provide useful guidance. A good rule of thumb is that after the second phone call, bring the client in for an in-person assessment, even if you think they are not in active labor. It is also important to allow ample time when evaluating a client for possible labor. Sometimes the
