### Responsibilities and Requirements of Board Membership:

- **Attendance:** Board members should regularly attend monthly meetings of the Board of Directors and standing Board committees (dark in August and December). Board and committee meetings typically occur on the 2<sup>nd</sup> Wednesday of each month, except for the Finance Committee (closed session) meeting the occurs the day prior. Meetings are held at the Association's offices at 621 South Westmoreland Avenue, Los Angeles, CA generally from 11:00 a.m. to approximately 3:30 p.m.
- **Participation:** Board members are asked to join and regularly attend meetings of at least two standing Board committees. The Board committees are: Executive, Local Government Relations, Legal, Membership and Nominations. Board members are also encouraged to regularly attend the Association's networking events and seminars occurring throughout the year, including major events such as the annual Installation Dinner and State Legislator Breakfast.
- **Term of Office:** Initial term of office is one-year. Thereafter, Board members may be reappointed for terms of two or three years.
- **Availability:** Board members are often called upon to be available to the Association's staff, lobbyists and/or volunteers to share their knowledge and expertise, and to provide needed assistance to the Association. Board members are expected to be advocates for the rental housing industry and assist the Association with gaining access to public officials, and formulating positions on proposed legislation and political candidates.
- **Annual Board Dues:** In addition to your annual membership dues, Board members are expected to contribute at least \$1,100.00 per year designated by you to either of our general fund, Legal Fund or one of our two political action committees.

- **Your Experience:** Professional experience as a rental housing provider, property manager or vendor servicing the rental housing industry is a must.
