- Applicants must be interested in perusing a career in the multi-family industry. Positions can include, but are not limited to; Leasing Professional, Maintenance Technician, Maintenance Supervisor, Property Manager, Assistant Property Manager, Marketing, Corporate Support, etc.
- Applicants are not required to have experience in the multi-family industry.
- Applicants cannot be eligible for; or receive monetary assistance from their employer.
- Applicants must provide a brief essay with the application. The essay should include why you would like to be considered for the scholarship, how completing the desired course will positively impact your pursuit of a career in the multi-family industry, and future career goals set for yourself.
- All applicants being considered for the scholarship will be interviewed. The interview may be via phone or in person.
- The scholarship will be used to cover fees related to the course in which you are enrolled. The AAGO Foundation does not reimburse for mileage or lost wages as a result of attending the required courses.
- The AAGO Foundation asks that anyone awarded scholarship funds give back to the AAGO Foundation by volunteering at a charity partner day of giving. (Contact [Melanie](#) for details)
- Recipients of the scholarship are required to abide by the attendance policies of the course and successfully complete any testing requirements within 6 months of course completion. Failure to complete course requirements will result in the recipient being financially responsible for all costs associated with the course at the non-member rate.
- Recipients may be asked for written or verbal feedback to further promote scholarship opportunities available through the AAGO Foundation.
- The AAGO Foundation does not provide employment opportunities; nor can guarantee an employment opportunity will arise by taking a course. The scholarship is provided to afford individuals with educational growth opportunities.
