### City of Wichita Non-Discrimination Ordinance effective 1/1/2022!

On October 12, 2021, the Wichita City Council voted to adopt a Non-Discrimination Ordinance (NDO), Ordinance 51-654, effective upon publication October 29, 2021, in the Wichita Eagle. Complaints will be accepted beginning January 1, 2022, in order to allow time for the implementation of enforcement processes.

This ordinance is intended to assure equal opportunity for Wichitans and to ban discrimination or segregation in housing, employment, and public accommodations based on age, color, disability, familial status, gender identity, genetic information, national origin or ancestry, race, religion, sex, sexual orientation, veteran status or other factors protected by law.
