



<u>Step 2:</u> Make the dressing. toss the balsamic vinegar, olive oil, vanilla, pepper, and a pinch of salt.

<u>Step 3:</u> Combine. Arrange 1/2 of the fruit in a bowl, gently layering the fruit. Peaches and ripe apricots Break down easily; layering, rather than toss, helps keep the fruit looking fresh. Drizzle about 1/3 of the dressing over the fruit. Distribute 1/2 of the basil.

Continue to layer and drizzle dressing.

Garnish with a few small bay leaves.
