SERVICE INSTRUCTIONS: If personal delivery is not accomplished you must mail this notice to the resident. If mailed, posting is not required, but recommended in addition to mailing. A posted notice must be affixed to a door by taping all sides or placed in a fixture or receptacle designed for notices. Posting alone does not constitute proper service. The location of the mailbox from which notice is mailed is also recommended information.

## INSTRUCTIONS TO PARTY GIVING NOTICE:

- 1. Include the names of all residents who signed the rental agreement.
- 2. The party giving notice should retain two (2) copies for possible courtaction.
- 3. If the premise is an apartment, include the name of the apartments and the apartment number.
- 4. If the residency is week-to-week, strike the words "Thirty-Day" in the title to this form, and insert the words "One-Week."
- 5. If the residency is month-to-month, the thirty (30) day notice must be given at least thirty (30) days before the periodic rental date; for example, if the rent is due on the 1st of the month, the notice must be given at least thirty (30) days before the 1st.
