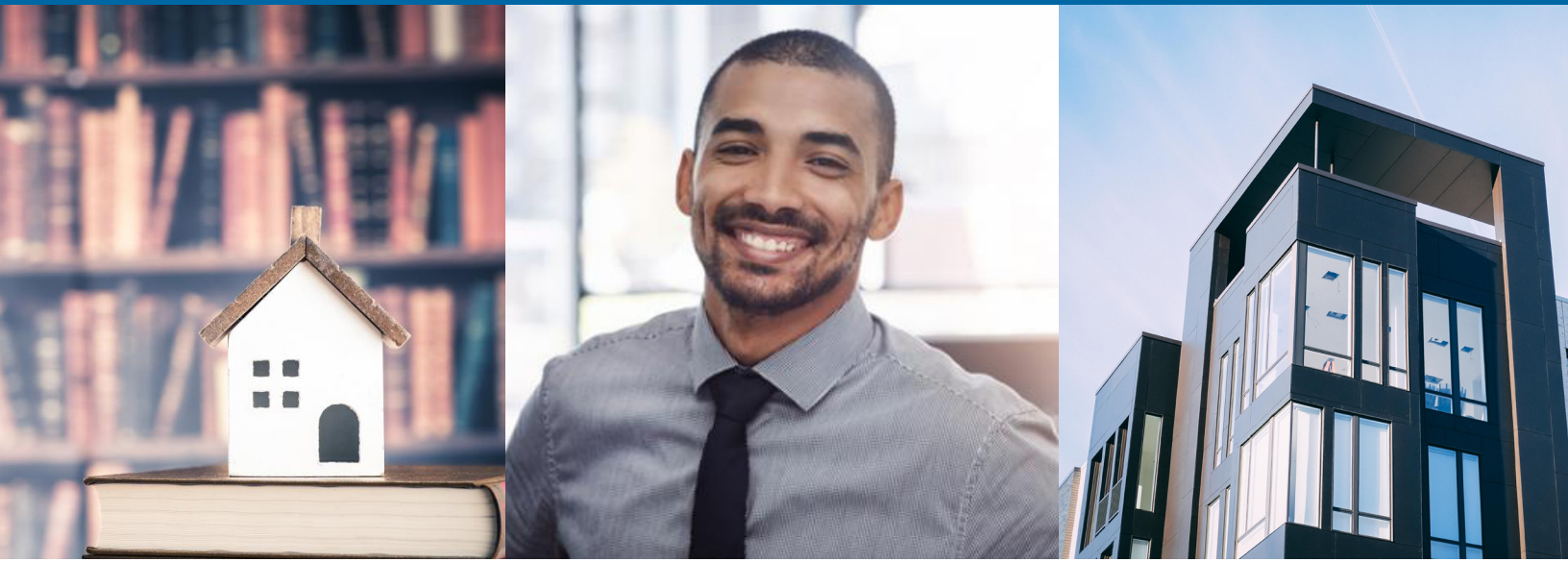


# Fair Housing for Onsite Personnel
