What COVID Funding Means for K-12

- The House has voted to approve a \$1.9T stimulus package
 - Would dedicate an additional \$170B to K-12 and higher ed
 - This is more than the previous two relief packages combined (\$30.7B and \$82B)
- Senate is expected to vote in the coming weeks
- This plan is called the American Rescue Plan
 - CARES Act: March 2020
 - COVID Relief Package: December 2020



How Much Will Congress Spend to Shore Up Schools?

The Covid-19 relief plans before Congress all dedicate billions to stabilizing education budgets amid deep losses in state revenue. But the amounts vary from bill to bill.

American Rescue Plan

\$63.5B: Avoid layoffs, close budget gaps, and hire more health staff \$59.5B: Social Distancing, PPE, and other materials \$46B: Meet the learning needs (closing the digital divide) and social-emotional needs of students



Funding Distribution

- All 50 states will receive funding
- Each state may reserve up to 10%
- States will largely tie the funding to Title I

- Re-engage students who have not been able to participate virtually
