## AASPA: Honorary Membership Award(s)

Honorary membership is granted to persons who have distinguished themselves in school personnel work by making outstanding contributions to AASPA and/or school personnel administration. Honorary members shall be entitled to participate in all activities of AASPA except voting and holding elective offices. They are also exempt from payment of membership dues and the annual conference registration fees (exclusive of meals, pre-conferences, event tickets, transportation and lodging). The honorary membership is granted for a lifetime. Non-members (at the time of nomination) or Retirees who have made an outstanding contribution to AASPA and/or school personnel administration are eligible for honorary membership.

Documentation for each category is required.
