- 1:30-Copies of the providence Minutes/Resolutions were passed to attendees.
- 1:43 Welcome and Introductions (Kashuba)
- 1:46 It was moved, seconded, and passed unanimously passed to approve the agenda for the 2015 Delegate Assembly.
- 1:47 It was moved, seconded, and passed unanimously passed to approve minutes from the 2014 New Orleans convention.
- 1:48 Saguenay Convention Report: Abrate gave a brief statement about the 2015 Saguenay convention.
- 1:57 Leadership Project: Lafond-Paquin reported there where 9 leaders. The program provids specific focus on chapters, leadership skills, the AATF, and organizations. The Leaders also learned about member recruitment and chapter development.
- 2:03 Executive Director Report: Abrate spoke about the move to the new facility. Abrate also thanked the staff, executive council, and chapter officers for their work in promoting the AATF.
