- 4** Once your **Rebate Claim** has been submitted, please view our Claims Process link for details on when you will receive your Remittance Statement and your Rebate Check.
- 5 Contact Us with any questions.**

*No receipts are necessary to process the rebates as we utilize Manufacturer salespersons to verify the information through their distribution. This makes the paperwork simple and requires minimal time on your part.*
