## Call to Order

Chair McReynolds calls the meeting to order at 1:00 PM.

## General Information Updates

## Past Meeting Minutes

 David Allain shared the location of all previous Specifications Committee meeting minutes and review the minutes from the April 16<sup>th</sup>, 2025, meeting. No comments.

# District Contractors Meeting – Asphalt Producers & Paving Contractors

David provided an overview of how the district level meetings were going. ACAF is advocating for small meetings to ensure production and placement of asphalt is satisfactory for both parties. ## Task Group Updates

## Updates on the Recycled Binder Availability (RBA) Specifications Task Group

 Patrick Pienkos provided brief updates for RBA Task Group. Upcoming meeting with SMO to review their implementation ideas.

## > Discussion on RBA Proposal sent to Specifications Committee prior

- David Shared the research proposal and encouraged the committee to review if not yet done so.
- General consensus from committee is that we can/should get more liquid into the mix.
- Running some of the examples from FDOT using RBA implementation methods: gyration levels seen as low as 38-40. When not adjusting for 4.0% air voids and keeping the same Ndesign, it resulted in 2% air voids.
- VMA up 1% Air voids down a percent is a suggestion by Eron Chambers.
- Eron also suggested 5% liquid minimum. Some designs are at 4.7-4.8.
- Jonathan Andrade said they run lots of TL-E, but could do a TL-C if we consolidated to just 75 gyration mixtures.
- One mix already goes everywhere. Parking Lots, other FOB, State Jobs. As long as it is an approved mix design by FDOT.

# Review of FDOT Specifications Proposed Changes for 26/27 and Beyond

> Steve went through Greg Sholars FPCM presentation to show the committee specification changes and future ones. No comments from the committee.

# Current Industry Challenges

## Discussion of Key Issues Facing our Industry. Open Forum

#### Binder Failures

 Steve shared updates that FDOT is working to shorten testing times to 2 weeks or less for binder results.

# Pavement Striping Removal

- David shared recent notice from DOT about paving striping being placed in the wrong locations and having to be ground, water-blasted, sand-blasted, etc. Some owners want mill and resurfacing is the paint is incorrectly place.
- Joe Meier said it has been escalated with FTBA and the striping industry. No ACAF involvement needed at this time.
- A couple contractors have had mill and resurface requested or required when striping was
  off a few inches.
- Matt Siegel said they have tacked it after water-blasting so open aggregate wasn't as visible. This was on a county job years ago.
- Gilsonite based GSB-88 rejuvenator used on FAA projects where they grinded the strips and then used the GSB-88 to cover. Successful method per contractors.

## FC-7, Aggregate Supply

- Mickey Concerning that it's just one primary aggregate product size.
- Rick You always need to have something to blend with to correct gradations because of tolerances from quarries. FC-7 is so highly dependent on #89s.
- Can we put more 3/8s in to help make a good blend for FC-7.
- Can we recommend correcting ½" control bands to 95-98 on the low end to 100 instead of 100% passing?

## Binder Grades in Use for Future

- David shared information that the FDOT had previously proposed removing both PG 58-22 and 52-28 and adding PG 58-28.
- David met with SMO and suggested we keep PG 58-22 after calls with binder suppliers.
   SMO said that might be what they do instead of 58-28. No issues with pushing to keep 58-22 per committee members.

# Solicitation of Research Topic Ideas for FDOT to consider

- David shared that he received three inquiries at the FPCM on research. One was about
  Fiberless FC-5/FC-7 with WMA technologies, another being removing hydrated lime from
  FC-5 mixtures as anti-striping agents are already added to the binders, and last being a
  comprehensive study on the use of vibration or oscillation.
- The committee expressed that the hydrated lime reduction has been asked for decades with no movement.
- The committee shared that the SMO has probably already completed research on the compaction comparisons.

# ❖ Task Force/Working Groups Formation

- Chair McReynolds mentioned forming a draft County Handbook/Guideline proposal for BOD to review and approve.
  - The idea would be a basic handbook explaining asphalt, design considerations, choosing a mix, etc. Asphalt 101 per se. Steve asks committee to email Steve or David if you are interested.
- No other task group ideas shared at the moment.

## NCAT Trip – Spring 2026

- David shared ACAF's plans to host another NCAT trip in Auburn, AL. Date will most likely be early February, 2026. This time for all ACAF members to attend if they wish.
