

# **TUITION & ATTENDANCE POLICIES**

## **TUITION POLICY**

The Program will consist of four sessions, scheduled to occur between December and April. Tuition for the ACEC/Alabama Leadership Development Series is \$4,500 per enrollment and is due when the program commences with Session 1. Tuition must be paid in full by Session 2, or a late fee will be applied.

Tuition covers the cost associated with the program, include Speaker, program facilitator and staff fees and expenses, facility, and equipment rentals; supplies; excursions/and or special events; and food and beverage costs. Tuition does not cover the cost for lodging.

## **ATTENDANCE POLICY**

Meeting venue agreements take place well in advance of the first session based on the number of committed delegates. Accordingly, cancellations for your enrollment in the program, within 30 days prior to the first session will incur a penalty.

Negotiated financial obligations are associated for each meeting venue, based on your commitment to the program. Guarantees for food, beverage, seating, supplies, and educational materials are reported to the meeting planner 72 hours in advance of each session to accommodate class delegates. Failure of a delegate to attend sessions WITHOUT NOTIFICATION BEFORE the 48-hour window, will result in the sponsoring firm liable for the delegate's share of lodging/food/beverage expenses for each session missed.

# TUITION PAYMENT/CANCELLATION POLICY

- 1. The program is four sessions. To cover programming costs, a tuition fee for this series is \$4,500.00 (Member Tuition) and \$5,000.00 (Non-Member Tuition), per enrollment. Tuition does not cover lodging.
- 2. Full tuition is due on acceptance to the program. Payment can be made by credit card, or ACH.
- 3. Lodging is not incorporated into the cost of tuition. Participants are required to make their own reservations. Room blocks will be available at each location.
- 4. Because contracts for each meeting venue are negotiated, ACEC Alabama has a financial obligation to pay based on your commitment to participate in this program. Accordingly, cancellations within 30 days prior to the first session will incur a penalty in the amount of \$2,000. Additionally, your sponsoring firm will be invoiced for your share of program expenses for each day, during each session missed.
- 5. Absences must be reported to ACEC/Alabama Executive Director and Program Coordinator at least

48 hours in advance of the LDS Session. Penalties will apply should you fail to report non-attendance. Please email rcasillas@aceca.org if you have questions, or to report an absence.
