Mr. Schoch has worked to improve the transportation industry by implementing innovative policies, encouraging excellence in employees and peers, and mentoring the next generation of transportation engineers.

As the Secretary of the Pennsylvania Department of Transportation (PennDOT) from 2011 through 2015, Mr. Schoch led PennDOT to institutionalize several new initiatives under the Next Generation Program to modernize assets, operations, and personnel to create new efficiencies; refresh and advance business practices and technology; and create a culture of continuous improvement. The success of this program led to tremendous savings and was instrumental in gaining the trust of the Pennsylvania Legislature. This paved the way for Mr. Schoch to spearhead the effort to pass Act 89, a \$2.4 billion per year funding bill and Pennsylvania's first transportation funding increase in decades.

Following his term as Transportation Secretary, he was retained by the Governor as senior advisor on transportation/infrastructure issues, focusing on implementation of the transportation bill and working across agencies to ensure the bill was efficient and cost-effective.

Mr. Schoch's project development experience ranges from managing final design and location studies for complex highway projects to major environmental impact statements. Mr. Schoch also has extensive experience in public involvement and agency presentations, innovative financing techniques, environmental policy, and streamlining the project development process.
