American Council of Engineering Companies of South Carolina Board of Directors Meeting Westin Poinsett, Greenville, SC March 15, 2019

<u>Call to Order:</u> ACEC-SC Chair, Cameron Nations, PE, called the meeting to order at 10:00 am. The following were in attendance: Keith Overstreet, PE, Jason Eppley, PE, Chuck Black, PE, Petrina Butler, PE, Matt Gehman, Jeff Mulliken, Ph.D., PE, Kevin Shoemake, PE, Mike Wooten, PE, Rick Fauteux, PE, Adam Jones, and Elaine Mikell. Additional attendees were: Shawn Epps, PE, (F&ME) Joe Jones (Jones, McAden & Associates) and Allison King (Jones, McAden & Associates.

Chair Nations told the group that due to an accident with Kyle Page's husband, she would not be attending this retreat. He asked the group to keep her and her family in their prayers.

<u>Consent Agenda:</u> Motion was made, seconded and passed to approve the February 7, 2019 Board of Directors Meeting Minutes.

Nothing to report on the Membership Report.

Financial report (Jason Eppley): Secretary/Treasurer Jason Eppley reported on the financial statement

- The balance sheet in the packet was incorrect, this is the accountants copy.
- The Year to Date income is \$438,275.08, expenses of \$284,062.57, net income of \$154,192.51.
- We are working to revamp the balance sheet and are cleaning up the Accounts Receivable and one of the CDs.
- Adam Jones said the \$30.29 for the Engineer Day at the State House lunch was miscoded, he said this item will be moving from line 45 (Minute Man Contributions) to 121 (Minute Man Match).
- There is still outstanding sponsorship monies and attendee monies.
- Motion was made, seconded, and approved to accept the financial report as given.

<u>Chairman's Report (Cameron Nations)</u>: Chair Nations said because of the Board Retreat follows the Board Meeting, the Chair's report would be given at that time.

Executive Director's Report (Adam Jones): Jones gave an update on legislation.

- o H3758/591 Joint & Several Liability-SCLLR
 - The "Fair Share Bil" has been introduced in the Senate as well as the House.
 - o Senate version was introduced by Shane Massey last week.
 - o S.591 is the companion bill of H.3758 in the House.
 - According to the Chair of the Subcommittee, there will be a hearing next week but the Bill is not on the agenda.
 - House Judiciary Committee Chair, Peter McCoy, has removed his name as a sponsor of H.3758.
 - Jones and Earl Hunter spoke to a member of the Speaker's staff on Feb. 13 to tell them McCoy is saying he doesn't know anything about the bill.
 - Jones thinks this Senate Bill will prompt a hearing.
- o S.401/H.3799 Utility Relocation Bill
 - This bill had a hearing almost a month ago, and we knew at the time that SCDOT had some issues with this bill, so we asked for the Bill to be carried over to work on.
 - SCDOT Secretary, Christy Hall, is insisting on adding a five-year sunset, even though this is the language SCDOT signed off on last year.
 - The Water Utilities lobbyist has been working with SCDOT's lobbyist and Leland to offer different language that gives the program checks and balances, but Hall has not changed her mind. Earl Hunter

has spoken with Senator Paul Campbell, sponsor, and Transportation Committee Chairman, Senator Larry Grooms, about the Bill and they want to see it move.

- o Jones said they are planning on call all the interested parties to see if they can work something out.
- Wooten said maybe this bill, as written, is not the answer.
- Wooten said municipalities are taking these roads back into the mix, and they are not equipped for the additional expenses.
- Wooten thinks this will have to be separate account from SCDOT to have this money available for municipalities. He suggested this idea come from ACEC-SC. He said the SIB is funded by the legislature and a certain amount of money from the gas tax goes to SIB. Wooten said the Chair of DOT, sits on sib board for one year only.
- Wooten suggested we should contact Senator Grooms and Senator Campbell.
- Wooten suggest we contact other engineering organizations together and build a consensus towards this. We should also mention this to Christy Hall. Cameron and Jones are to reach out to the engineering associations. Should we reach out to the utility companies and associations and set a meeting. Jones will talk to Earl Hunter about this.

o S.107

- This Bill is one dealing with dams.
- o Bill defines what a dam is, and changes the circumstances of when DHEC can tell a dam owner to tear down, repair, remove a dam.
- This bill also provides a tax credit up to \$50,000.00 for repairs to a dam if they are required.
- o Bill was amended and gives a carve out to level three, low threat dams, as well.
- o Bill passed out of Senate Agriculture and Natural Resources subcommittee yesterday, February 14.

o S.266 State Guard

Jones said this bill has not moved and is not sure there is enough support to get it to move. While there
is no one against the bill, the bill has no real champion.

H.3263/S.455 (Military & Spouse Licensure)

- These bills dealing with licensure by military spouses have both moved across the lobby to the other bodies.
- Both were amended from their original versions, so, Labor Licensing and Regulations has to approve their licensure.
- Jones likes the Senate version better because it has stronger checks and balances, so, he hopes that is what passes.

H.3622 (Lobbyist definition)

- This bill dealing with the definition of lobbying in regards to county councils, city councils, state agencies, etc. has not moved since the last hearing, where he testified.
- Jones doesn't think the Lobbying Bill will come back up, but if it does it will probably be different from the original.

o Building Code Adoption

- This bill has seen movement.
- A few weeks ago, AGC, Building Code officials, MCA, AIA, and Jones were summoned to Senator Hugh Leatherman's office. Home Builder's Executive Director, Mark Nix, was there as was LCI Chairman Thomas Alexander.
- While the group expressed concerns, they kept them to three items they thought would make the most impact with the two Senators.
 - Cost of the new codes.
 - FEMA money if we are not on the most current codes.
 - Insurance fears by going away from the I-codes.
 - Leatherman wants the adoption period at five years.

- The adoption cycle was one of the many concerns from last year's bill; so, if this is the only item the Chairman wants, we decided we can work on this.
- We are working on compromise language which hopefully he will accept that will leave commercial codes at three years, but moves the residential to five years.

Business Transparency

- o This is a Bill that has surfaced in several states that deals with "transparency".
- A software firm, TransparentBusiness, has developed a software to track and verify billable time and is
 pushing the bill. This firm is now seeking to legislatively mandate this type of system with state agencies
 and presumably the federal government.
- There is a national effort underway to enact legislation in the states-possibly at the federal level-to impose new accounting and tracking requirements on professional and technical services industries working for government agencies.
- The firm is offering retainers and even company stock to attract and hire lobbyists around the country to push this legislation. They have hired a lobbyist in SC.
- The legislation is titled the "Secure Transparent Overview Process for Reducing Abuse, Underutilization and Deficit Act (Stop Fraud Act) and requires contractors to "use software to verify that hours billed for work under the contract that are performed on a computer are legitimate. The contract must specify that the agency will not pay for hours worked on a computer unless those hours are verifiable by the software or by the data collected by the software".
- The legislation requires that agencies have real-time or retroactive access to data collected, tracking keystrokes and "mouse events" and taking screen shots every three minutes, as well as real-time access to the cost status of each task. The bill would prohibit the contractor from charging the agency for access to or use of the verification software (unlike other overhead expenses).
- There are many concerns with this legislation, and it fails to account for safeguards that already exist in the regulatory framework governing A/E contracts.
 - Engineering services encompass a broad range of activities that go far beyond computer key strokes, such as work in the field, meeting with clients, team discussions, non-computer based drafting and designing, and other activities.
 - Particularly for work for state DOT's, the services provided by local firms are already subjected to thorough oversight and accountability, both by the agency and through the relevant federal rules based on the Federal Acquisition Regulations (FAR). ACEC has been proactive over the years in improving this oversight-working with Congress to establish a unified set of rules based on the FAR to better manage A/E contracts, and ongoing work with FHWA and AASHTO to ensure compliance.
 - Existing regulatory safeguards provide for contract negotiations that include scoping, estimated
 hours and not-to-exceed limits. Agencies closely scrutinize cost proposals and won't allow for
 anything more than is necessary for the work product.
 - Project management and oversight also includes milestones, deadlines for deliverables, status meetings, scrutiny of invoices, and other accountability and supervision of contractor work.
 - Projects audits look at supporting documentation to compare and account for hourly billings,
 e.g. employee timesheets, and FAR overhead audits also look at accounting systems, time
 keeping, etc. to ensure accuracy and adequacy of internal controls.
 - The Qualifications-Based Selection (QBS) process relies on a review of past performance and quality of work as a further safeguard against firms guilty of fraudulent billings or overcharging.
- Adam will talk with delegation that is going to the Convention in Washington, DC.
- o Jones said he will send out the information on the Stop Fraud Act.

Wooten said a local attorney contacted him about Mechanics Lien Laws concerning engineering, planning, zoning. They are not covered under the statute that would allow someone to bring mechanics lien against someone being stiffed.

Wooten said it was his understanding that you have ninety days to bring suit or it is null and void. He said this does affect the engineering profession and planning, zoning should be protected. He said this is covered in Sec 29.41.

- o Jones said he has had some engineers join him at the State House on Wednesdays.
- He had a Future Leader graduate attend and Mitch Cooper came on Engineers day, which was the first week of the legislature running full speed. Cooper spent 4.5 hours with Jones in committee meetings.
- o Jones invited everyone to come to the State House, and he said some in the membership breakfast expressed an interest in attending.
- o Jones said Wednesday, March 20th is Surveyors Day and invited surveyors to attend.
- Jones said the Winter meeting was held in February and there were 83 attendees. He said there was good feedback from both tracks.
- Jones reminded everyone the ACEC Annual Conference and Legislative Summit is May 5-8, 2019 in Washington,
 DC.
- o Consulting Congress Day is May 7 and he encourages everyone to attend.
- Sleeping rooms are selling fast so register ASAP.

George McCall, SCSPE Past President, has invited everyone to come to his house Wednesday evening, June 5. He is offering a PDH session in his blacksmith shop and will have food and drink for attendees.

ACEC-SC National Directors Report (Rick Fauteux):

- Fauteux reminded everyone of the ACEC Annual Convention and Legislative Summit May 5-8, 2019, at the Washington Marriott Wardman Park.
 - April 4th is the last day for reduced registration pricing.
- o Fall Conference will be October 13-16, 2019 in Chicago, IL, at the Sheraton Grand, Chicago, IL.
- ACEC Annual Convention and Legislative Summit 2020 will be at Washington Marriott Wardman Park, April 26-29, 2020.
- o Fall Conference will be October 28-31, 2020 at the Marriott Marquis in San Diego, CA.
- ACEC National PAC at \$167,392 of \$1,081,135.00 goal (15.5%).
- ACEC Planning Cabinet-SubCommittee #2 Younger Member Participation at MO and National Level-submitted five Final Recommendations to the Executive Committee. Two items of note:
 - Create and distribute an ACEC National 101 video that will describe the value proposition to younger members as to why they should join, participate, and support ACEC in their careers. Video should address participation at the MO and national level.
 - O Budget for a pilot program to provide financial support to the Member Firms/Organizations to help defray the cost of fees for younger members to attend a National Conference. Budget \$50,000.00 per year (starting FY 2019/2020) and initiate a pilot program that proves discounted (or zero) annual conference rates for emerging leaders/young professionals and offer to member organizations for distribution. Recommended that the appropriate committees address (i.e. membership, education, etc.) the development and implementation of the pilot program.
 - This is just a recommendation and will be up to ExComm. to review and discuss.
 - Membership Committee is continuing discussion on the development of a new MO Membership Commission Program. This was discussed and feedback received at the recent NAECE meeting. Daphne Bryant, ACEC Sr. VP Membership and MO Services, was continuing to research the success of the previous program and the potential financial impacts from a new program. This program will be discussed at the upcoming Membership Committee Meeting in DC.

Kylie Page will be the new PAC person for SC. She will be getting back in touch with the Board members about donating to the PAC.

Committee Reports:

Transportation Committee (Chair Melvin Williams)

- Melvin Williams was not in attendance so Adam Jones gave the Transportation Committee report.
 - Jones said the Transportation Committee met on February 7
 - There was movement on design build.
 - ACEC-SC/SCDOT Partnering Committee met February 14.
 - Chris Gaskins gave the Design Build report
 - 13 projects in construction right now
 - o SCDOT taking Right of Way away from Design Build.
 - MEBA box getting away from.
 - o Peer exchange meeting between several states was helpful.
 - Debating size of projects that will be design build.

Environmental Committee (Chair Keith Overstreet)

- Overstreet said he thought the presentations at winter meeting were good, appropriate and timely. He thought Paul Grosser was a perfect fit.
- He will talk about this during the retreat.
- Overstreet asked if there is a place for the environmental committee to communicate to members.
- Information comes from ACEC concerning environmental and infrastructure issues.
- O How can this information be distributed?
- Wooten said the Ingram Dunes case goal was to hold up project indefinitely. Stan Barnett is the attorney.

BRE Committee (Chair Chuck Black)

- Member Firm Scholarship Applications are on the website now
- College Student Scholarships should go out soon. He has contact info for the accredited schools.
 - Schools have requested the application be sent to the financial aid offices due to fraudulent scholarships.
- The Engineering Excellence Awards venue was an excellent location and received rave views. He congratulated Thomas and Hutton for winning the Palmetto Award two years in a row.
- Future Leaders will be addressed during the retreat.

Communications Committee (Chair Ricky Ward)

- Keith Overstreet gave Ricky Ward's report because he was not there
- o Ricky talked with Robin at Grits Designs about a new website, which the launch will be by the first of April.
- App is still an issue and will tackle after the website is up. Probably move away from where we are now and maybe hire Grits Designs for this too.
- o Overstreet said it looks like we are on track with the website and the committee staffed by members.
- Committee needs to make sure what is on the website is what they presented to be put on the website.

Membership Committee (Chair Kevin Shoemake)

- Jones said the Board packets contained what is sent to prospective members
- The flyer ACEC-SC means business will be updated.
- o There will be a list of the Board of Directors, Committees, Slides of the PowerPoint and Collateral from National.
- There will be grammatical and spellings corrections that need to be made.
- QAQC process to review everything that goes out.

- Gehman reached out to potential members but it will be helpful when the website and app are updated. It will
 also be helpful ot have marketing materials on-hand.
- o PAC Oyster Roast and Silent Auction were a big success, will definitely have one again next year.
- Motion was made, seconded and approved to congratulate Matt Gehman and Theresa McClure on a great event.

Nominating Committee (Chair Kylie Page)

- Kylie Page was unable to attend, Rick Fauteux gave a brief report.
- o Fauteux said the committee met once.
- o Committee is currently waiting on people to submit names for the potential Board members.
- Jones said a copy of the Bylaws are in the Board packet.
- o The process of who can serve on the Board are noted in the Bylaws, for sake of transparency.
- Nations asked if there was any discussion on the bylaws, maybe the wording for nominations on the floor needs to be changed.
- There is a disconnect between nomination submissions and voting.
- The wording now is three past presidents put up the nominations for the Board of Directors. The wording does
 not say, the last three past presidents. This is important because should one of the last three past presidents
 pass away, or leave a member firm, that would be an issue.
- Ad Hoc committee will meet to discuss.

Other business:

- Jason Eppley will have a report next month on ACEC-SC financial reserves and there will be information in the packets.
- There will be a committee meeting soon on this
- There is close to ½ million in reserves at this point, \$438,000.00
- Jones said Melvin Williams had asked if ACEC-SC would consider a sponsorship for a Larry Grooms fundraiser.
 Motion was made and passed to be a sponsor. Discussion would take place during the ACEC-SC PAC meeting.
- This motion was tabled until the PAC meeting

Wooten apologized for not being able to make all board meetings. Jones said years ago video conferencing was used. Check into using video conferencing for every other Board meeting. Jones said the reason it was discontinued was people were not engaging. Wooten said he called into the meetings he did not attend and asked if this practice was a problem. No one voiced concern.

Motion was made to adjourn the meeting, seconded and passed for adjournment at 11:40 am.

 - Dwight Loftis is running for the seat left vacant by SC State Senator Timmons, and Jones asked if ACEC-SC could make a PAC donation to his campaign.
 - Jones provided the Board with Loftis voting record and activity with ACEC-SC.
 - o Walked on the veto override bill of the Roads Bill.
 - Voted for the Pipe bill.
 - o Has one vote for, one vote against and one walk on transportation funding
 - Jones said Loftis has received PAC donations in the past.
 - Wooten knows Loftis and supports him.

- o \$1000.00 is the maximum that can be donated
- Motion was made, seconded and passed to make a PAC contribution in the amount of \$500.00 to the campaign of Curtis Loftis.

ACEC-SC/SCDOT Partnering Committee Meeting Thursday, February 14, 2019 SCDOT Headquarters-Room 306 955 Park Street, Columbia, SC

<u>Call To Order:</u> The meeting was called to order by Melvin Williams, Transportation Committee Co-Chair at 10:02 am. This was the first meeting of 2019. The following were present: John Boylston, Petrina Butler, David Montgomery, Jeff Mulliken, Tameika Bostic, Clem Watson, Bradley Cain, Randy Roberts, Brian Dix, Jen Necker, Julie Barker, Phillip Sandel, Burt Shumpert, Claude Ipock, Randall Young, David Taylor, Chris Gaskins, Rob Bedenbaugh, Tony Cooper, Tameeka Boston, William Cooper, Ricky Ward, Darrin Player, Aaron Livingston, Phillip Hutcherson, Adam Jones, and Elaine Mikell.

After introductions were made, Williams presented the November 8, 2018 minutes for approval. There was a motion made, seconded and passed to approve the minutes from the November 8, 2018.

<u>ACEC-SC Executive Director's Remarks:</u> Executive Director Adam Jones reported that the ACEC-SC/SCSPE Winter meeting was on Tuesday, February 12 and there were over 80 attendees.

The ACEC-SC Engineering Excellence Awards were held on February 5, 2019 at the USC Alumni Center and there were 15 entries and there were around 100 people in attendance.

Jones went over a list of bills ACEC-SC is tracking at the General Assembly. Bills that effect ACEC-SC and SCDOT were discussed in some detail. Jones said he had testified against H. 3622, a bill dealing with the definition of a lobbyist, earlier that month. Jones said as the bill is written consultants may have to register as lobbyist if they were talking to state agencies, county governments, all the way down to school boards. Jones said the bill's author said no one that does not have to register now would have to register after it passes, but Jones said that is not how it written. Jones said ACEC-SC will continue to oppose the bill.

Jones said ACEC-SC is monitoring S. 401, the bill dealing with utility relocation. SCDOT's Randall Young, PE, said the SCDOT helped craft this bill last year because SCDOT is having significant delays on utilities-sewer and water relocation. He said this bill would help smaller utilities, but large utilities would see a benefit as well. SCDOT supported the bill last year, and they are doing their due diligence and looking at it again this year. He added that the Legislative approved a proviso last year to look at the process, and SCDOT are reviewing requests now.

SC DOT Program Update: John Boylston, Director of Preconstruction, SCDOT, thanked the Transportation Committee for allowing him to speak at their meeting, he enjoyed the interaction. There are three topics on his update.

 Freight Network-There are five Interstate widening projects that have been approved by the SCDOT Commission. These are in the next three-year program but they are trying to get them ahead of the curve and are programming some planning funds for these. He said there are many questions about interchanges and bridges when talking about the widening. The SCDOT is going to put out some feasibility studies. That way they know what the scope is and will be able to deliver the project quicker. Planning is leading the effort, and they may look to consultants for help on the feasibility report.

- Bridge Program-Julie Barker has done a great job on this. She has worked on this for a year and a half and are now looking at year four of the program.
 - Year 1: 28 Bridges in construction are in-house projects but some went to consultants.
 - Year 2: 19 Bridges that will engage consultants and 20 out of 34 went to consultants.
 - Year 3: 20-32 Bridges-20 of which will go to consultants.
- Tentative Ad List
 - More bridges scheduled to be let in the first half of this year than all of the last couple of years.
 - Closed and Weight restricted 16 bridge packages in District 2 that will come out as a package.
 - o Bundling more bridge packages will speed up procurement.

Leland Colvin, Deputy Secretary for Engineering, SCDOT, and Brent Rewis came into the meeting. Colvin said the State of the SCDOT was very well received last week by the House and the Senate. He said they are searching for where they have the gaps. He said this was a busy legislative session but not a whole lot that impacts this group. He said there is a DBE Bill that may not go anywhere. He said the majority of DBE work is subcontractor work versus prime work, which is overwhelming what DBEs are getting. He said they are to trying get a goal-based law. The gaps are off interstate programs. There is more interstate capacity progress happening along with mass transit. When the tax credits end; they will need areas that need money.

Brent Rewis said Rural Roads/Rural Interstates have been ranked an approved by the SCDOT Commission. They are allotted \$1 million for each segment.

- I-26 out of Orangeburg
- I-95 from Georgia to Highway 17
- I-26 to I-95 from Charleston
- I-85 to Clemson from Georgia
 - Working on the feasibility study now. Will start soon on the I-26 to Orange and I-85.
 Feasibility reports in April.

Standing Committee Reports:

ACEC-SC/CAGC/SCDOT Joint Design-Build Committee (Chair-Chris Gaskins)

Chair Gaskins began by thanking ACEC-SC for all of their assistance. He said the Design-Build Subcommittee has been very active and has been great to bounce off ideas. He said there are personnel changes. Jeff Mulliken and Bryan Shiver have rolled off the committee but Elham Farzam and Paull Raad will be taking their place. Pete Weber and Chuck Gallant will be coming on from AGC. Mary Ott will be rolling in from Hydro.

Gaskins said there are 13 Projects in construction:

- In 2019, I-26 widening is a fixed price \$500 million.
- Emergency Bridge Replacement packages will be let.
- I-85 over Rocky Creek imminent, FRQ will be out March 4^{th.}
- Close and Load restricted bridge project will be coming out in Fall 2019.

- There are 16-17 Bridge projects to be let in District 2.
- Carolina Crossroads, RFQ rolling out in a couple of weeks, on February 26.

There is not much to update about 2020 projects as they continue to look at cash flow. The website is updated every month, and the website gives more specific updates.

Discussion Topics are:

- Right of away acquisition process-The SCDOT takes on the responsibility of just compensation and has a reasonable plan. Gaskins said look for this plan to roll out.
- SCDOT has the ATC database, which no other DOT in the country has. This database looks at all
 ATC's that SCDOT has ever had. This is allowing SCDOT to look at how they approve and
 evaluated ATC's along with the statistics on ATC's. SCDOT is continuing to accelerate design
 reviews.
- IMAR responsibility (i.e. I-20 over Highway #1)
 - o I-277 will use NEPA Box on this project
 - o IMR-they are thinking of getting an IMR upfront and is working with the Design Build team and the Federal Highways Administration after it has been awarded.
- Design Reviews-It still feels like the SCDOT is being accused of slowing the process but they are working to accelerate this process. ACEC plays a key role with partial submittals. Gaskins asked committee to "continue to help us get better on this topic".
- Peer Exchange review happened late last November with ten states and it was very productive.
 He said it was good to know what the SCDOT is doing is being utilized in other states. The Peer Exchange report is forthcoming and will be on the SCDOT website.
- Gaskins said a lot of discussion is going on about utilities. In contract; utility exchange is
 ongoing. The Utility Subcommittee is going to talk to discuss this issue in conjunction with the
 Design Build Joint Subcommittee.
- Working on staging between projects that are not adjacent to each other. Working to determine what will take precedence. There are several projects coming down the pipeline.
- Performance Evaluation-they have been through two rounds thus far and continue to get feedback from design teams. This will be reflected in the meeting minutes.
- Project Size updates-there are big projects coming soon. They are continuing to debate the size
 of these projects to determine if the billion dollar projects are the best for the agency. There will
 be no update until we know where we are.
- March 20 will be the next meeting.

Bradley Cain asked what was included in the coordination between the projects. There will be none until one project is complete.

Professional Services Committee (Chair-Jennifer Necker)

Chair Jennifer Necker said the committee had not yet met this year but will meet soon. The committee will be working on several items:

- Final vetting or availability in the two-tier solicitation process.
- Small Purchase Program- An internal committee is working on this.
- Lump Sum Contracts-In the process of researching how this is done in other states.

• Limited notice to proceed-working on this issue.

Melvin Williams, S&ME, said member firms had lots or procurement and invoicing questions at its last full Transportation Committee meeting.

Ricky Ward, RK&K, said the Limited Notice to Proceed (LNTP) was also discussed. He asked if the SCDOT can allow invoicing while working under a LNTP. He asked if there was a structural impediment for the department to do this.

Randall Young, SCDOT, emphasized that invoicing for work performed could not officially happen until a signed contract is in place. The LNTP is a binding contract. However; it is issued to help advance the work that needs to get started early with the understanding that a contract would be signed soon, which would allow consultant to invoice for this work. He said the SCDOT does NOT give out LNTP everywhere. They do it very strategically and work performed by Consultants under a LNTP will be paid. SCDOT expectation is that they shouldn't receive invoices until the actual contract is signed. Young asked if the Consultant's subcontractors understood the LNTP process that they also will not get paid until the contract is signed, which means that they will have to carry this cost for their work. If the subcontractor is not able to carry this cost under a LNTP, then the SCDOT needs to be informed. The SCDOT is assuming Consultants have the cash flow to either pay a sub or will let the sub know that they will not get paid until the actual contract is signed. The DOT is signing LNTP with this understanding. It is the responsibility of the Consultant to inform the SCDOT about problems that may exist with signing a LNTP. Petrina Butler asked if there would be a time frame attached to a LNTP. Young stated that the SCDOT needs to know if a time limit is needed for a LNTP and you do not have cash flow to cover the subcontract work. SCDOT assumes if you are signing the Limited Notice to Proceed, you have the means to cover your subs.

- When it comes to contract modifications or financial issues, you need to let your PM know immediately. Do not assume you will be compensated later for work performed outside your scope or that the PM will cover this work. Contractors are in this position to assist SCDOT, but they do not want to put others in a bad situation.
- Jennifer Necker suggested contractors talk to the Sub and the Prime and ask if they are looking for a LNTP. She has had this conversation with a PM and it was a good conversation.

Mid-Level Designers Group (Chair Phillip Hutcherson)

- Hutcherson takes over chair position from Petrina Butler
- There are two new SCDOT staff on the Mid-Level Designers Group Subcommittee: Tony Cooper and Tameika Bostic. He said there has been significant turnover since the last meeting. They are excited about Tony and Tameika being on the subcommittee. The last meeting was on November 15 and the subject was open roads. Out of the 90 people that came, 52 were Consultants with the remaining from SCDOT. The next meeting is April 10, 2019.
- Meetings will continue to be held in the auditorium.

ACEC-SC/SCDOT Fall Conference (Chair Melvin Williams)

Chair Melvin Williams said the ACEC-SC/SCDOT Fall Conference is December 3, 2019 and this will be the Tuesday after Thanksgiving. Emily Swearingen will chair the Conference again this year.

The Engineers Conference is March 26 and 27 at the Convention Center. Registration is open now on the Clemson University website. Register early as there is a cap on the number of attendees for the general session. Joey Rhodes and Adam Humphries are accepting topics.
