ACEC-SC Board of Directors Meeting April 2, 2020 WebEx Conference Call

<u>Call to Order:</u> ACEC-SC Chair, Keith Overstreet called the Board meeting to order at 10:02 AM. The following were in attendance: Keith Overstreet, PE, Jason Eppley, PE, Cameron Nation, PE, Petrina Butler, PE, Ricky Ward, PE, Ben Temple, PE, Jeff Mulliken, PhD, PE, Melvin Williams, Chuck Black, PE, David Taylor, PE, Theresa McClure, Bryan Shiver, PE, Kylie Page, PE, Adam Jones, Allison King, and Matteah Taylor. A motion was made to approve the consent agenda by Black, seconded by Eppley, and passed. It was noted that the minutes needed to be corrected to reflect others that were in attendance: Ben Temple, PE, Tom Jordan, PE, Melvin Williams, Ricky Ward, PE, David Taylor, PE, Shawn Epps, PE, Brice Urquhart, PE, and John Walsh, PE.

<u>Financial Report:</u> Vice Chair, Jason Eppley gave the financial report in the absence of Secretary/Treasurer Matt Gehman:

- ACEC-SC has an income of \$539,890.07 versus expenses of \$380,415.79 for a net income of \$159,474.08.
- Executive Director Adam B. Jones said the anticipated end of the year income cannot be projected at this time due to current COVID-19.
- Jones spoke about the postponement of the Oyster Roast and the Golf Tournament. He said the loss of the Oyster Roast would only affect the PAC account balance, but that if the Golf Tournament was to be canceled, we would have to pay the Scholarships out of the Education Fund.
- He said the only known expenses for the rest of the year is JMA's management fee.

A motion was made to approve the financial report by Black, second by Mulliken, and passed.

<u>Chair's Report:</u> Chairman Keith Overstreet said ACEC-SC has written a letter to the Governor asking for Engineering Services to be listed as essential services in the event of a Shelter in Place order due to COVID-19.

Overstreet turned this portion over to Jones as he had been communicating with the Governor's office.

- Jones said currently Engineers and Engineering Services are currently listed as essential services.
- He informed the Board that they can go to the SC Department of Commerce and fill out information to be listed as an essential business.
- Jones said firms may want to have their employees have a letter stating they are essential with them if they are working in the field or traveling.

A question was asked about ACEC-SC PAC checks being issued. Jones said they would get the checks out to the legislators with primary challengers next week.

Chairman Overstreet then turned the meeting over to Budget Committee Chairman, Jason Eppley, to discuss the 2020-2021 proposed budget.

Eppley said the Budget committee met and prepared a conservative budget as ACEC-SC needs to be prepared for the aftermath of COVID-19 pandemic. He said the major changes from prior years are:

- Instead of increasing dues by 3%, a 3% decrease to dues is being proposed. Eppley noted this will subsequently decrease the other budget items that are a function of the dues (PAC, MinuteMan, and ACEC National Dues).
- Reduce the anticipated income for all of our events
- Reduce the ACEC-SC/SCDOT Annual Meeting income.

Eppley noted the committee is proposing a balanced budget. Jones and Eppley then walked the Board through the proposed budget line by line.

• Eppley asked Jones to reduce the anticipated income from the SCDOT Annual Meeting to the budgeted amount in 2019-2020.

After going through the budget line by line, Overstreet asked the Committee to go back and reduce expenses to balance the budget after reducing the income from the ACEC-SC/SCDOT Annual Meeting. Jones said he would have a second draft to the Committee the next day. Overstreet closed by saying the Board would vote on the budget at the May Board Meeting.

Executive Director's Report: Executive Director Adam B. Jones gave the following report:

Legislative Report:

- The Legislature is currently not in session due to COVID-19 and will report at the "Call of the Speaker/President"
 - o Expected to return Wednesday, April 8, 2020.
 - They came back briefly to vote on the Stimulus Package
 - Designer Fair Contracting Bill 2nd Draft was provided to the Board of Directors
 - It is slated to be introduced when they return
 - SC Frivolous Civil Proceedings Sanctions Act
 - Conversations have been on going with LCI Staff
 - o Fair Share Bill
 - Still in House Judiciary Subcommittee
 - QBS
- Will continue to work on this once they report back
- Right of Entry
 - Will continue to work on this once they report back

Jones informed the Board Melvin Williams, S&ME, is interested in running for Vice Chair at ACEC National. The Board will nominate Williams for the position.

SC Engineering Conference & Trade Show

- Currently scheduled for June 11 13, 2020
- Have talked to Hotel about another date due to COVID-19

- SCLLR has extended the Engineer's renewal deadline to September 30, 2020;

<u>ACEC National Director's Report</u>: National Director Kylie Page, PE reported:

 - Considered holding the convention virtually;
 - Engineering Excellence Award Gala will be held in the fall;
 - May try to host Consulting Congress meeting in conjunction with the EEA Gala

- Transportation David Taylor reported the Partnering Committee meeting was held March 5, 2020.
 - The meeting was basically a question and answer session;
 - Eppley recommended the Board stand firm on their position with the partnership;
 - Discussion about SCDOT's new procurement procedures not following QBS occurred
 - DOT did not directly entertain those concerns

- Mulliken has been speaking with Karen McCabe the speaker about hosting it virtually

 - Ben Fanning approached Jones about doing webinars for ACEC-SC
 - Jones has a called scheduled with Fanning to discuss

 - ACEC-SC's intern is currently working remotely
 - o Her last day with JMA is April 24, 2020
- Membership Committee No report

Other Business:

Jones said Gehman asked for an ACEC PAC contribution for Rep. Nancy Mace's congressional race. Jones said he spoke to National and ACEC PAC does not usually support incumbent opposition, but if this is important a letter from the Board requesting the funds would be needed. Jones said Congressman Cunningham does not take PAC money. The question was raised is Rep. Mace in line with ACEC-SC's values. Jones said she has been a critic of Secretary Hall and SCDOT. He said she is a fan of Infrastructure, but he can put together a report card for her.

The Board went into Executive Session at 11:40.

Nations made motion to come out of Executive Session, Black seconded, and passed.

Butler made a motion to adjourn the meeting, seconded by Nations and passed. The meeting adjourned at 12:22PM.

The next meeting is scheduled for May 7, 2020 at Davis & Floyd, in Columbia.

ACEC RECOVERY AGENDA:

WATER INFRASTRUCTURE

Congress should include a robust water infrastructure component to an infrastructure-based recovery agenda in 2020, built around investments in ports and waterways, flood control, hydropower, and water and wastewater programs under a new Water Resources Development Act (WRDA). A critical priority for this agenda should be significant increases in funding for the Clean Water Act (CWA) and the Safe Drinking Water Act (SDWA) state revolving fund (SRF) programs and other grant and financing mechanisms to support community drinking water and wastewater needs. This investment is particularly timely to assist states and municipalities to recover from the pandemic and address public health threats.

Key Points

- » Industry and labor studies of past water infrastructure investment have found that \$1 billion invested in water infrastructure creates over 23,000 jobs.
- » According to the EPA, drinking water and wastewater systems will need at least \$750 billion over the next 20 years to maintain current levels of service.
- » There is a \$100 billion backlog of authorized Corps of Engineers water resource projects.

ACEC's Water Priorities

- » Reauthorize WRDA to support more resilient design, increase funding and financing options to reduce project backlog, and remove barriers to non-federal sponsor investments.
- » Increase funding for the Clean Water and Safe Drinking Water SRF programs and require the use of Qualifications-Based Selection (QBS) for engineering on federally funded drinking water projects.
- » Reauthorize and provide increased funding for the Water Infrastructure Finance & Innovation Act (WIFIA) program.
- » Support the USDA Rural Development Water & Wastewater Loan and Grant Program with increased loans and grant funding.
- » Ensure that policies to analyze and regulate PFAS follow an evidence and risk-based assessment process.
- » Oppose so-called "open competition" language that seeks to mandate materials such as plastic pipe and interfere with decisions that should be made by licensed engineers.





ACEC RECOVERY AGENDA:

TRANSPORTATION

The centerpiece of a national infrastructure-based recovery agenda should be a multi-year reauthorization of the nation's surface transportation law – the FAST Act – with sustainable and growing revenues to support critical highway and transit projects. Congress has an opportunity to provide the resources and program enhancements to upgrade our current roads, bridges, transit and rail systems to address years of deferred maintenance and rehabilitation, while modernizing our networks to accommodate expected growth in population and freight movement, incorporate new technologies, improve safety, and strengthen resilience.

An injection of federal funds will also help to stabilize state and local economies and backstop infrastructure budgets that have been severely impacted by the response to the coronavirus pandemic and significant loss of revenue. Investing now is critical for near-term economic recovery and laying the foundation for long-term growth.

ACEC's top priorities for a long-term surface transportation and economic recovery bill:

Robust Funding Supported By User Fees

- » Raise revenues to provide for the long-term solvency of the Highway Trust Fund and substantially grow investment.
- » Support the continued development of alternative funding mechanisms such as mileage-based user fees.
- » Incentivize private investment through TIFIA financing and lifting the cap on Private Activity Bonds.

Improved Infrastructure Resilience

- » Provide financial and other resources to equip public agencies with the tools to routinely and holistically assess and manage risks.
- » Develop the necessary standards, research, technical support, and inter-agency processes to cost effectively mitigate future hazards.

Contracting Policies to Ensure Qualified, Innovative Engineering

- » Avoid restrictions on the ability of State departments of transportation to partner with private sector firms on any phase of project delivery.
- » Promote procurement practices that ensure a qualifications-based process for engineering and design services and encourage innovation, competition, and efficiency in contracting.

Streamline Regulations for Efficient Project Delivery

» Continue to advance resources and flexibilities to simplify regulatory reviews while ensuring environmental performance and public interest protections.

ACEC Business Survey

Project Approach

The following recommended scope of work has been prepared based on our most recent discussion. It is our recommendation that ACEC-SC consider conducting a statistically valid survey that targets principles and decision makers from engineering firms in the South Carolina. Sample size will be max possible based on the list provided. ETC assumes a list of close to 900 contacts will be provided. It is assumed that ACEC-SC will recruit major engineering firms to participate and will provide ETC Institute with the name, email address, and telephone number of the representative from each employer they would like to survey. ETC Institute has the capabilities to recruit these individuals, but this would result in a significant increase in the number of hours and resources that would need to be devoted to this project. It is our goal to maximize your investment in our services, this is the reason we suggest ACEC-SC recruit individuals from employers in the region to participate and deliver that information to ETC Institute.

ETC Institute understands that the purpose of this study is to gather statistically valid data with respect to issues and topics related to ACEC.

Task 1: Survey Preparation

- O 1.1 Review Previous and on-going studies. ETC Institute will review related studies that are on-going and those that have been completed in the region to ensure that relevant information is integrated into this study. ETC will work closely with ACEC-SC and need assistance from them developing the questions to be included on the survey.
- 1.2 Conduct Work Sessions with the Project Team. ETC Institute will meet with ACEC-SC to discuss the goals and objectives for the project. Some of the topics to discuss during this meeting will include the survey administration process, project timelines, possible questions to ask on the survey, and types of analysis ETC Institute can provide.
- o 1.3 Design the Draft Surveys. Based on the results of the initial work session and guidance from ACEC-SC on questions, ETC Institute will design the survey instrument. An initial draft will be submitted within two weeks of the completion of work session. A second draft will be completed after ETC Institute receives input from ACEC-SC on the first draft. Based on the comments received on the second

draft, ETC Institute will submit a third draft for approval. ETC Institute will leverage our experience with these types of workplace studies to design and develop a survey instrument that meets all of the goals and objectives of the project. ETC assumes the survey length will be 20 to 25 questions.

1.4 Sampling and Survey Methodology. As a part of this task, the sampling plan and the methodology for administering the surveys will be finalized. ETC Institute recommends utilizing a hybrid paper/internet/phone combination methodology. Employers who have been recruited to participate will receive a link to an online survey. Those employees who do not have email addresses will be given a paper copy of the survey or cati will be administered. The paper surveys will be shipped by ETC Institute and will contain a postage-paid, return reply envelope that will be addressed to ETC Institute.

Task 2: Conduct the Survey and Analyze Data

- 2.1 Conduct the Employer Surveys. Once the final survey instrument is approved, ETC Institute will administer the survey methodology finalized by ACEC-SC. The following procedures will take place for the paper/internet combination methodology.
 - ETC Institute will work with ACEC-SC to develop a communication plan for the survey. Advance publicity can significantly enhance the response rate.
 - ETC Institute can provide recruitment costs based on the assumption that ETC Institute will recruit businesses (with the help of advance letters from ACEC) to participate, secure a point contact, and coordinate with contact to disperse the online/mail back surveys to employees. This recruitment is not included in this scope, and this scope of work assumes ACEC-SC will recruit employers and deliver the recruitment data to ETC Institute for survey administration purposes.
 - ETC Institute will create an online survey and website to allow principles and decision makers with internet access and a company email to fill out the survey online.
 - ETC Institute will also create a paper version of the survey. If requested, paper copies of the survey can be sent to employers. ETC Institute will coordinate the shipping of paper surveys with each employer.
 - The employers who have been recruited will receive a link to participate in the survey. Multiple reminder emails/calls from ETC will be sent out during the data collection period to help maximize the response rate.
 - o A member of ETC Institute's staff will coordinate with the recruited employers and will ensure ample follow up attempts have been made.
 - Postage-paid, return reply envelopes will come directly to ETC Institute for data entry if paper surveys are requested by the organization.
 - If response rates are low, ETC Institute has the capability of conducting on-site surveys. However, any on-site visits will significantly increase the cost of our services and would need to be discussed with all parties prior to any on-site work being conducted.

To ensure any non-English speaking employees are well represented, ETC Institute can do the following:

- The cover letter that is sent with the paper version of the survey can contain information that is translated into other languages.
- ETC Institute can establish a toll-free phone number that non-English speaking residents can call. Non-English-speaking interviewers from our firm will be available to administer the survey over the phone. Other languages can be made available if needed.
- A demographic question can be included on the survey that asks which languages are spoken at home. This will allow ETC Institute to better understand how non-English-speaking respondents are represented in the sample.
- o 2.2 Perform continual QA/QC on the collected data. ETC Institute recognizes that quality control will be critical to the overall success of the project. If decision-makers in the region do not believe that the survey data are accurate, the results of this study will have little value to the community. The project's success, in many ways, will be dependent on the management of data collection and processing activities. Although it is important to ensure that high standards of quality are maintained during all tasks, failure to achieve these standards during the data collection and data processing portions of the project will jeopardize the overall success of the project. ETC Institute has an ongoing quality assurance program in place. This program has been developed and refined through our experience with hundreds of studies that involved the design and administration of surveys. Our quality assurance program will be directly monitored by the company CEO, Christopher Tatham. The program is designed to give clients "error free" results, and all employees at ETC Institute are directly involved in the program. Chris Tatham is an active member of the Market Research Association. The quality control methods used by ETC Institute have been reviewed by external organizations including the Water Research Foundation and the United States Office of Management and Budget. Some of the basic elements of ETC Institute's quality assurance process include the following:
 - Training of interviewers. All interviewers are required to complete ETC Institute's in-house training program. The program teaches new employees the appropriate methods for conducting interviews, how to respond to different situations that may occur, and how to properly record responses. All interviewers work directly under the supervision of an experienced supervisor. All interviewers will receive specialized training for this survey before they begin conducting interviews.
 - Data entry fields will be limited to specific ranges to minimize the probability of error. The data processing system that will be used by our firm for the study alerts data entry personnel with an audible alarm if entries do not conform to these specifications. This ensures that responses are accurate and complete.
- 2.3 Conduct Analysis and Provide Results. ETC Institute will provide the following: series of frequencies distributions for all questions on the survey, cross tabulations, and other statistical analysis of the data that will help with the understanding the survey results. At a minimum, this analysis will include:

- An assessment of the overall results of the surveys
- Importance-Satisfaction Analysis (Quadrant Analysis) this is based on the overall design of the survey and is only achieved if specific design standards are maintained.

Task 3: Prepare Draft and Final Reports

- 4.1 Prepare Draft Final Report. ETC Institute will prepare a draft final report that
 documents the entire survey effort and analysis of results. The draft final report will
 be presented to ACEC-SC for comment and approval. At a minimum, the draft report
 will contain the following:
 - Executive summary of survey methodology and findings
 - Charts depicting the overall results of the surveys
 - Tabular data that shows the overall results from each survey along with crosstabulations of the results for selected variables as appropriate
 - A list of priorities that are based on the Importance-Satisfaction Analysis (if applicable questions are asked)
 - A copy of the survey instrument(s)
 - A breakdown of responses by employer this is only available if a significant number of surveys are completed at a specific worksite
- o **3.2 Submit Final Report.** Based on the feedback from ACEC-SC, ETC Institute will prepare a final report that incorporates the comments and corrections requested.
- 3.3 Provide final data files. ETC Institute will submit all data files and other relevant materials to ACEC-SC. The data files will be turned over with a complete description of the file contents, meanings of codes, and all other information necessary for the ACEC-SC to undertake independent subsequent analysis of the data.

Fees and Cost

The total fee to administer the business survey is \$20,816. This includes the report and submittal of the final database.
