Leadership Institute Application Evaluation Criteria:

- 1. Employee of an ACEC Wisconsin Member Firm (25 points)
- 2. Employed out of a firm's Wisconsin office. (10 points)
- 3. Applicant's answers on Self-Evaluation Questionnaire. (35 points max)
- 4. Sponsor's answers on Sponsor Recommendation Form. (20 points max)
- 5. Firm and applicant diversity status (10 points max) ACEC Wisconsin is committed to being a welcoming, diverse, and equitable organization. The diversity of the Class of 2026 is important to us, and diverse candidates are highly encouraged to apply. Factors taken into class selection
  - a. Firm characteristics (i.e., firm size, DBE status, geographic area)
