RULES & REGULATIONS

ELIGIBILITY. An entry participant, and anyone to whom an entry participant legally transfers an entry, must be either a business entity or an individual 21 years or older at time of entry purchase. Individuals buying on behalf of a business or legal entity must be legal representatives of the business and must, themselves, be 21 years or older at time of entry purchase.
