Committees work together allowing AMAP to represent the modified asphalt industry.

Each Committee has a Chair and Vice Chair who manage the Committee's activities, assignments, and goals. There are Members of and Friends of the Committee, which only differ in the ability to vote on any decision or issue that may appear. Responsibilities and terms are outlined in each Committee's Charter and Guidelines posted on the AMAP website. Each committee is required to meet a minimum of twice a year with a recommended quarterly meeting depending on the activities of the Committee. Activities are assigned internally to each Committee and may be split into Task Forces at the discretion of the Chair and Vice Chair.

**Events:** This committee plans and organizes the annual conference, including speaker line-up and coordination with the Education Committee to create the Workshop.

**Technical:** This committee generates and reviews all technical information, including presentations for workshops and the annual conference. Information is generated through white papers, member company or Advisory Committee requests, and the needs of the industry.

**Education:** This committee is responsible for the Spring Workshop and Annual Conference Workshop. The group reviews and finalizes all content and speaker line-up.

**Membership:** This committee is responsible for recruiting and maintaining AMAP's membership. The Membership Committee assists new members with on-boarding and involvement in the organization. This committee also addresses any general membership questions.

**Communications:** AMAP's brand guidelines are managed by this committee. Members also ensure the marketing efforts keep current members up to date as well as attract new members. These committee members represent AMAP at various industry events.

**Advisory:** This committee consists of industry advisors for the Roofing and Paving industries, as well as distribution of state, local and federal agencies. Through this committee, AMAP maintains relationships with other organizations and agencies while keeping a pulse on the industries' hot topics. This partnership promotes open communication regarding the use and education of modified asphalt throughout the Roofing and Paving industries.

**Finance & Audit:** AMAP's healthy financial balance is the responsibility of this committee. Members of the committee also optimize investments and maintain funds for future scholarship awards.
