ELIGIBILITY

The building must be a member, or managed by an entity that is a member, in good standing with both AOBA and BOMA International if that entry is to progress to the regional and/or international level.

- A separate application must be submitted, along with payment of \$250 per property, for each entry. To be eligible, applications must be completed and received in the AOBA Office by no later than March 15, 2019.
- The building may not have won in the same category at the international level during the last 5 years, nor in a different category at the international level during the last 3 years.
- The building must be at least 1 year old from the date of occupancy of the first tenant by June, 2019.
- At least 50% of a building's space must be used as office space to be considered for all categories except for the Industrial and Retail categories. The Industrial category must have more than 5% and less than 50% office area as measured by BOMA standards.
- The building must win at the local level to advance to the regional level, and must win at the regional level to advance to International.
- All TOBY entries except industrial are required to be ENERGY STAR benchmarked and provide a copy of their current year Statement of Energy Performance. If a local winner advances to the regional level, they will be required to share their data with BOMA International in the ENERGY STAR online portfolio manager.
- ESPM profiles shared with BOMA reflect the new updated data, and any building that reports performance prior to the update will not be verifiable through their profile. In order to ensure the TOBY scoring in the energy conservation section is fair since this update affects the EnergyStar score, the awards committee has voted that all TOBY entrants submitting for 2019 must upload a copy of the SEP generated from the ESPM after August 26, 2018.
- For any building that enters the competition at the local and regional level that may encounter a change in management and/or ownership and wins at the International level, the award will be presented to the management company/owner at the time of the original entry.
