### **Erin Bradley Joins AOBA as Vice President of Government Affairs, Maryland; Succeeds Ron Wineholt on Advocacy Team**

She also has extensive experience in Prince George's County, where she worked with various departments, including the Office of Legislative Affairs and the County Health Department. Ms. Bradley holds a Master's of Public Administration degree from the University of Georgia, with a concentration in local government and policy. Her Bachelor's degree is from Wofford College in Spartanburg, South Carolina.

"We are excited to build on Erin's experience and insights as we advance our members' priorities and continue to partner with the public sector in Maryland," said Ms. Whiteman.

"Erin is well prepared to hit the ground running in the wake of Ron's successes in the 2019 General Assembly," added AOBA Executive Vice President Peggy Jeffers.

Mr. Wineholt will work alongside Ms. Bradley and Ms. Whiteman until his May 31 retirement. Prior to joining AOBA in 2012, Mr. Wineholt was the lead lobbyist for the Maryland Chamber of Commerce and had served on the staff of committees of both the Senate and House in the Maryland General Assembly. "We have been the beneficiaries of Ron's unique experience and talent; he commanded the total respect of legislators, staff and AOBA leaders alike," Ms. Jeffers said. "We wish him all the best as he enjoys his well-earned retirement, while AOBA builds on his legacy of achievement."
