




Fulfilling the mission: Public policy advocacy


- APBA collaborates with behavior analysts, consumers, and policymakers; BACB (where applicable); advocacy organizations
- Provides
 - Consultation and information via meetings, phone and video conferences, webinars, email, posts on social media
 - Model language for legislation, rules/regulations, sunrise applications, etc.
 - Analyses of proposed legislation and rules/regs
 - Tips about likely pitfalls and opposition and how to avoid or counter them
 - Testimony and/or help in preparing testimony
 - Supporting resources (talking points, research summaries, etc.)
 - Letters of support
 - Written comments to legislators, regulators
 - Cheerleading



Licensure and other regulation of ABA practitioners

- Input provided on licensure bills, laws, rules, other aspects of regulation to date:

- Developed APBA model licensure act (updates and replaces BACB model act)

Licensure and other regulation of ABA practitioners

Health insurance coverage of ABA services

- Medicaid
 - Disseminated model language for State Plan Amendments (SPAs) or rules re: EPSDT coverage of ABA services for beneficiaries with autism to multiple states
 - Provided input on proposed Medicaid SPAs or rules in many states
- Coverage by private or public health plans
 - Provided input on bills or proposed rules in several states (e.g., to remove age caps from autism insurance law in Utah)



Health insurance coverage of ABA services

- TRICARE Autism Care Demonstration
 - Participated in provider conference calls hosted by Defense Health Agency
 - Collaborated with Behavior Analysis Advocacy Network on webinar on billing documentation and ethics for providers
 - Arranged for Defense Health Agency personnel to give workshop at 2018 and 2019 conventions



Health insurance coverage of ABA services

- CPT codes for adaptive behavior (ABA) services
 - Participated on Steering Committee for ABA Services Work Group (representatives from APBA, BACB, ABAI, Autism Speaks State Government Affairs)
 - Submitted application to American Medical Association CPT Editorial Panel to modify 2014 Category III (temporary) CPT codes and upgrade them to Category I (February 2017)
 - 8 modified codes were approved as Category I and 2 modified codes were approved to remain Category III, effective January 1, 2019



Importance of the Category I CPT codes

- Signifies that
 - Clinical efficacy of the services has been documented in research that meets rigorous AMA standards
 - Services are performed by many qualified healthcare professionals and are consistent with current medical practice
- Should reduce denials of coverage on the grounds that ABA services are "experimental," "unproven," or "not medically necessary"
- Over time, should result in more uniform, consistent adherence to code descriptors than was the case with the Category III codes
- Not specific to any diagnosis or client population, creating possibilities for obtaining reimbursement for ABA services for any client with adaptive skill difficulties or maladaptive behaviors (but additional advocacy will be required)



Other ABA Services Steering Committee activities

- Developed and distributed
 - Code conversion table showing relationships between essential ABA services, Category III and other codes, and new Category I/Category III CPT codes (October 2018)
 - Article in CPT Assistant describing new codes and intended use published by AMA (November 2018)
 - Suggestions for provider communications with payers (October 2018)
 - Supplemental guidance article with clinical examples (January 2019)
 - Message regarding Medically Unlikely Edits (MUEs) for the new codes (December 2018)
 - Summary of payer policies on the new codes (being updated periodically)
