# LETTER FROM THE EDITORS

Dear Review of Higher Education Readers,

Another year full of challenge and success has passed and we are grateful to the editorial team for its considerable efforts, to the editorial board for their expertise and insightful reviews, to the ad hoc reviewers for the detailed feedback they provide to authors, to our authors for the care they put into their scholarship, to the Association for the Study of Higher Education (ASHE) and Johns Hopkins University Press (JHUP) for their support, and to our readers for looking to *RHE* for the strongest scholarship the field of higher education has to offer. We believe *RHE* is and should remain one of the top journals in the field publishing high quality empirical, theoretically-grounded scholarship about the functions and effects of higher education.

The works published in *RHE*'s pages this past year come from varying disciplinary, conceptual, and methodological perspectives. The authors challenge themselves, other higher education scholars and practitioners, institutional leaders, and policy makers to rethink current ways of operating and to make changes that will benefit the diverse and diversifying communities that come together to work and study in colleges and universities. While departures are difficult, we are excited to announce four additions to our team. We are extremely fortunate to have **Tania D. One of our goals is to provide manuscript authors with thoughtful, critical feedback that offers the authors opportunities to strengthen their work and increase its chances for publication in *RHE* or another journal. For reviewers, we have ensured that they see how other reviewers and we as editors have commented on manuscripts and have posted tips for writing good reviews on the ASHE website. For authors and reviewers, we presented and will present again at the ASHE conference to give scholars a more complete understanding of the publication process, elements of good articles and reviews, and pointers on crafting and responding to reviews.

We look forward to the coming year as we continue our work. We hope you see in the pages of *RHE* the scholarship that makes you (re)think, prompts changes in policy and practice, and encourages additional scholarship. Thank you for your interest in, and support of, the *Review of Higher Education*.





Table 7 reports the primary focus of the manuscripts submitted to *RHE* between September 1, 2020 and August 31, 2021, as identified by the author. As shown in Table 4, a wide range of topics were represented in submissions. The largest numbers of submissions were in the areas of "Student Outcomes/Student Success" (47, 15%), "Faculty Issues" (30, 10%), "Diversity Issues" (29, 9%), and "Graduate Education" (27, 9%).

### PRODUCTION TIMELINE

### MANUSCRIPT ACCEPTED

~ 1 MONTH

Once a manuscript is accepted to *RHE*, authors have 30 days to complete final revisions (as specified in acceptance letter) and send the finalized manuscript and signed Publication Agreements for all authors to the *RHE* Managing Editors.

### FINAL CHECKS

1-2 WEEKS

Managing Editor will complete the First Production Technical Check, ensure that comments from the accept letter are addressed, then send along to the Editor for a final review of the manuscript. Managing Editor will reach out to author with any withstanding issues.

#### COPYEDITTING

3-4 WEEKS

Finalized and approved manuscript is sent to the Copyeditor. Copyeditor focuses on formatting and grammar to ensure APA 7th edition compliance and sends back within 2-3 weeks. Managing Editor and Editor review copyedits and save a new "clean" copy.

### FIRST PROOF

~2 WEEKS

The clean copy is sent to JHUP for First Proofs. JHUP's product team sends back proof typically within 2 weeks. Managing Editors review first proofs alongside copyedits and complete second technical check for all formatting and conversion related issues.

### **PROOF REVISIONS**

~3 WEEKS

Managing Editor sends first proof and copyedited manuscript (with tracked changes) to authors for review. Author feedback is requested within a one week turn around. Managing Editor revises proof to include author feedback, then sends edited first proof to Editor for review. Final edits are sent to JHUP.

### **ONLINE FIRST AND DOI**

3-4 WEEKS

JHUP produces final proof and sends to Editorial Team for review. Upon approval, article is given a DOI and placed in the Ahead of Print section in MUSE. It will later be slotted into an upcoming issue of *RHE*.





Figure 2. @RHE\_ASHE Twitter Engagement Rate (Right)





### Article Views

There were 149,015 article views recorded between September 1, 2020 - August 31, 2021. Of the views, 59,657 were to PDFs of articles with the remainder to the html version. Muse currently consists of 702 journals and <u>RHE ranks 5th amongst all Muse journals</u> in terms of total usage for the current year.



### RHE Subscriptions

The following data correspond to the period beginning September 1, 2020 and ending August 31, 2021. The data represent figures regarding *RHE*'s subscription rates, circulation and electronic access of articles and journal issues for the same time-period. According to Johns Hopkins University Press, there were 795 subscribers to Volume 44, which contains Issues 1-4. This number represents 774 members and 21 institutional subscriptions to the print versions as well as 51 libraries that also subscribed to the electronic version. An additional 1,114 members have opted for the electronic-only version of the journal.
