Join us Saturday night for a "Taste of Boston"

Enjoy a "Taste of Boston" and get acquainted with your colleagues in ASHE, Saturday evening, November 2 at 6:30 pm in the Boston Park Plaza. The reception/buffet will include saffron linguine with sea scallops, corned steamship of beef, roasted cranberry glazed turkeys, baked stuffed oysters, crabcakes, swordfish brochettes and other New England delicacies.

Following the buffet, Minneapolis humorist and historian Jane Curry will provide a tour of fictional Pandora College, where today's young ladies combine the wisdom of the Great Books (written by the Great Men, of course) with the "ladylike deportment necessary in regaining their rightful place as society's custodians of modesty."

The performance satire "Just Say Know: Educating Women for the 21st Century" explores how the use and misuse of science, the recurring nature of biological arguments and the back-tothe-classics movement have influenced women in higher education. Administrators at Pandora College are eager to "turn back the destructive impulses" of contemporary feminism and embrace the standards of 19th century Victorianism. Among other things, Pandora is noted for its curfew, in which "young men are allowed to visit our students in the dorms, but they are restricted to the lobby and must have at least one foot on the floor at all times. Gymnasts must be accompanied by a chaperone."

Curry, a former A&W carhop and crayon wrapper, earned a Ph.D. in American Culture from the University of Michigan and has taught English in high school and college. Since 1983 Curry has taken her solo performance based on the writings of humorist Marietta Holley across the United States and to foreign countries; "Just Say Know" made its debut in 1988.
