Mary Burgan is General Secretary of the American Association of University Professors. She has been on the English faculty at the University of Indiana since 1964, and has served as Chair of the English Department and Associate Dean of the College of Arts and Sciences. She has held positions on various IU councils, in the Modern Language Association, the Association of Departments of English, and the Lilly Endowment Workshop on the Liberal Arts. In 1996 she served a one-year term as a member of the Board of Directors of the American Council on Education.

Richard Chait is Professor of Education at the Harvard Graduate School of Education. He previously held faculty positions at the University of Maryland and Case Western Reserve University and served as Associate Provost at Penn State. He was co-director of AAHE's New Pathways project and will, in January, be principal investigator for the Harvard Project on Faculty Appointments, a three-year, \$1.9 million sponsored research program.

"How Are We Doing? Tracking the Quality of The Undergraduate Experience From the 1960s to the Present"

In his presidential address, George Kuh will discuss trends over the past 30 years in the nature of undergraduate student experiences and learning and personal development outcomes.

George Kuh is Professor of Higher Education and Associate Dean of Faculties at Indiana University Bloomington where he also directs the College Student Experiences Questionnaire Research and Distribution Program. His current administrative assignment is an opportunity to use the research on college students and institutional performance to shape university policies and practices in ways that foster student success.

"The Challenge Before Us: Re-Inventing the Academy for the Millenium"

Yolanda Moses, President, The City College of New York Saturday, November 8, 8:30 a.m., Salons E & F

Yolanda Moses, a nationally recognized cultural anthropologist, is the tenth President of City College of New York. She comes to CCNY from California State University-Dominguez Hills, where she was Vice-President for Academic Affairs and Professor of Anthropology, a position she had held since 1988. From 1982 to 1988 she was Dean of the College of the Arts and Professor of Social Science (Anthropology) at California State Polytechnic University, Pomona.

Dr. Moses was selected by the Ford Foundation as one of four consultants in the country to evaluate its diversity projects in universities and colleges across the nation. She chairs the American Council on Education commission on the Status of Women, and the United Negro College Fund National Advisory Board for Service Leming. Dr. Moses is a member of the National Science Foundation's Advisory Committee for Social, Behavioral and Economic Sciences and was recently elected to the Board of Trustees of the Ford Foundation.




