Check Your Connection

- Update your Member Compass: Make sure your member portal is set up, so you never miss an opportunity to access information, registration, or update your team's information. You can even access invoices and pay online through your portal!
- We are texting! Opt-in by providing your mobile #, you will receive important notices and reminders. Especially helpful if you are on a committee!

Budgeting Your Dues for 2025

When Does My Membership Renew?

Each member's annual membership runs from January 1 - December 31. Invoices for the coming year's membership are sent out November 1st.

What are the Membership categories, and how are my membership dues calculated? Industry Members:

Dues are billed based on a base fee + per-unit fees for all the residential rental units/properties owned, operated, built, developed, and/or managed by the company, within the 11-county jurisdiction of the Austin Apartment Association.

- 0, or 10 units or less = \$300 annually
- 11-2,000 total units = \$375 base fee + \$2.25 per unit
- More than 2,001 units = \$475 base fee + \$2.00 per unit

*All industry members must provide the Association with a list of all properties, prior to or at the time of renewal, and verify total units.

Supplier Members Dues: \$550

Supplier members are billed a flat rate annually for membership in the Austin Apartment Association.

FAQs

Can AAA bill properties directly for renewal?

Yes! AAA can send individual invoices to each property in the portfolio.

The management company/managing owner is the **parent member** AAA, and properties are **sub-company** members with AAA. As such, invoices may be broken out per property with an opt-in, and a \$40 admin fee per property. Unless otherwise requested by a supervisor, the management company will be sent **one invoice** for all the properties in their portfolio. These requests must be made prior to November 1st of each year (aka COB 10/31).

*Note: the base fee is not included in this calculation, and not divided among the individual property invoices.

If properties (aka sub-companies) are billed directly, the parent Industry member will still get an invoice for the base fee.
