On behalf of the members of Building Owners and Managers Association (BOMA) International, we strongly recommend Congress continue supporting the ENERGY STAR Buildings program at current funding levels. The ENERGY STAR program plays a critical role in the commercial real estate industry, enabling building owners and operators to analyze energy performance and optimize building operations. Importantly, investors and tenants know that certified buildings will have lower energy costs, which will save them money.

The United States commercial real estate industry is a significant driver of the nation's economic engine and one of the foremost employers in the country. BOMA, founded in 1907, is a federation of 81 U.S. local associations whose

members are located in nearly every congressional district across the United States. As the leading trade association for commercial real estate professionals, BOMA represents the owners, managers, service providers, and other property professionals for all commercial building types, including office, industrial, medical, corporate, and mixed-use. U.S. private-sector office buildings served by BOMA's local associations represent 8.6 billion square feet of office space, support 1.7 million jobs, generate \$75 billion in salaries and income, and contributes \$148 billion to the national economy.

BOMA International strongly supports the ENERGY STAR Buildings program and urges Congress to carry on their non-partisan vision set forth decades ago and continue this important program. Our industry relies on the ENERGY STAR Buildings program as a proven business tool that advances innovation, building performance, and energy efficiency. While private-sector solutions have an important role, ENERGY STAR remains the industry standard for the following reasons:

- ENERGY STAR offers nationally recognized, trusted tools and certifications that no other program can replicate.
 - o Annual building inspections provide continual credibility for owners and occupants.
- ENERGY STAR saves resources that uplift the industry and those who depend on it: in 2024, it helped save 230 billion kilowatt-hours of electricity and avoided \$14 billion in energy costs.²
- ENERGY STAR certifications drive competitiveness and tangible economic returns by increasing sales prices and rental rates by up to 16 percent.
- ENERGY STAR certified buildings provide customers and investors the expectation of lower energy bills and a higher-quality experience.
- EPA's ENERGY STAR Portfolio Manager provides performance metrics on energy use, water use, emissions, and waste generation/disposal critical to the success of the program.
 - Over 330,000 buildings—comprising nearly 25 percent of U.S. commercial building floor space—utilized Portfolio Manager in the last year, underscoring its widespread adoption and effectiveness.³
 - The data is trusted within real estate markets, a value that a third-party entity could not reproduce.
 - o Dozens of state and local governments use the data as the IT backbone of their voluntary programs and benchmarking and disclosure and Building Performance Standards laws.
- ENERGY STAR plays a critical role in the commercial real estate industry, enabling building owners and operators to evaluate energy performance, enhance building operations, and demonstrate successful commitments to investors and tenants.

As a government run program, ENERGY STAR Portfolio Manager facilitates trusted data collection and distribution, occupying a pivotal place in the market that privatization could not effectively fill. Programs at the state and local level support Portfolio Manager as the accepted and logical tool to avoid regulatory chaos with the "patchwork" of local requirements for measuring and managing building energy use, which supports energy demand management and growth. BOMA also uses the data for our high-performance building
