

# **Step One: Locate your District**



- 2. Enter your HOME address in the dialog box below the 'Bing' logo.
- 3. Click 'Find Address'

Using the legislator's email (in blue), write your legislator to let him/her know you are a constituent and will be in the State Capitol on Wednesday April 3<sup>rd</sup> and hope to connect with the legislator between 1:00pm-2:00pm.
