# Report of the Forty-Eighth General Meeting of the Catholic Biblical Association

The forty-eighth general meeting of the Catholic Biblical Association of America was held August 12-15, 1985, at the University of San Francisco, San Francisco, California. The first general session was opened by the Rev. Daniel J. Harrington, S.J., vice president of the association, at 8:00 P.M. on Monday evening. The Rev. John LoSchiavo, S.J., president of the university, welcomed the members of the association. Professor Paul Achtemeier then delivered the presidential address, "An Elusive Unity: Paul, Acts, and the Early Church."

### Sessions on Wednesday, August 14

The task forces and continuing seminars resumed their work during the first part of the morning. Two simultaneous sessions then heard presentations by Alice L. Laffey, R.S.M., "My Patron Vashti," and by Anthony J. Saldarini, "The Pharisees in Palestinian Society."

Bernard B. Scott was presider and homilist and Harry Hagan, O.S.B., was leader of prayer for our midday Service of the Word.

The general session in the afternoon listened to a panel discussion on "The Use of Scripture in the Bishops' Pastoral on Economics." The moderator was Terence J. Keegan, O.P.; and the panelists were David Hollenbach, S.J., Bruce J. Malina, and Richard J. Sklba.

CBA president Paul Achtemeier called the annual business meeting to order at 4:00 P.M. In the absence of Msgr. Myles Bourke, Joseph Jensen, O.S.B., gave the report of the chairman of the Board of Trustees. Aloysius Fitzgerald, F.S.C., then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. The Executive Board has decided to raise the subscription price of OTA from \$11 to \$14. Grants approved by the Executive Board include: (a) \$10,000 for the Syrian Consortium for 1986, contingent on a positive evaluation by our archaeology committee of a new proposal made by the team. The team's plans for the 1985 season were revised, and our committee is currently evaluating the revision. (b) \$10,000 for the Memorial Stipends program established in 1982. (c) \$2,500 for the Elenchus Bibliographicus Biblicus. (d) \$1,000 for the translation project of the Studium Biblicum Franciscanum. (e) The Executive Board also decided to raise the stipends for the visiting professorships at the Ecole Biblique and the Pontifical Biblical Institute from \$1,500 to \$6,000, plus travel costs. (The host institution supplies board and room.) The change begins with the 1985-86 academic year, and will be continued on a trial basis for three years. (f) The Executive Board has established a new fellowship program for young scholars. It will be open on a competitive basis to those who have recently completed their doctoral degrees; further details are published in this issue of CBQ. Each grant will be for \$8,000 plus travel expenses. The program will begin in 1986-87, and will be continued on a trial basis for three years. Jensen reminded the membership that next year's meeting will be at Georgetown University in Washington, DC. The dates will be August 6-9, 1986, since the members strongly supported the proposal to move the meeting earlier next year in order to allow SNTS members to attend. The following meeting will be in Chicago, at De Paul University, August 17-20, 1987. Jensen expressed gratitude to those who have obtained invitations from their institutions and urged members, especially those on the West Coast, to continue seeking invitations for future CBA meetings. The Executive Board has appointed James Fischer, C.M., to the Board of Trustees. It has also decided to propose to the membership that Frederick L. Moriarty, S.J., be made an honorary life member of the association (this proposal was presented to the membership under New Business for a vote). The CBA office has a new computer system, including programs designed for our unique needs. This has allowed us to accept the invitation to handle the responsibilities of subscription fulfillment for New Testament Abstracts. With the new computer system in place, Jensen hopes to circulate an information questionnaire to the membership and to produce a new member supplement. Information about computers will be available to members from a computer committee established by the executive office. Finally, Jensen expressed his thanks to the local arrangements committee and especially its chairman, Daniel Kendall, S.J., for all their work in making this year's meeting run smoothly. A total of 217 registrants (including families) are present.

John Meier gave the report of the editor of the CBQ. This year's statistics are similar to last year's. Thirty articles were published in 1985, totaling approximately 412 pages. Seventy-five articles were received, of which sixteen have been accepted, twenty-six rejected, and thirty-two are in process; one was withdrawn. The backlog

problem mentioned last year is largely resolved, and the journal continues to appear on schedule. Meier addressed some points of CBQ editorial policy. A query has been received whether CBQ will publish a slightly reworked version of material (e.g., a chapter) from a book or dissertation that is to be published elsewhere as well. The decision is not to publish such material, in order to use our limited space for original material not otherwise available. Contributors are reminded and urged to follow the CBQ style sheet scrupulously. Particularly when manuscripts are prepared on computers and word processors, certain problems can arise: e.g., some printers, both dot-matrix and letter-quality, position the underscore in such a way that lower-case q and lower-case q become indistinguishable. Further, footnote numbers must be superscript. Finally, even though proportionally spaced print and justified margins may be possible on a printer, manuscripts prepared this way cause difficulties for our typesetters; please use fixed-width print and do not justify margins.

Bruce Vawter, C.M., reported on OTA. Circulation is currently ca. 1,950, of which 1,682 are paid subscriptions. In 1985 we published abstracts of over 900 articles and ca. 120 books. Our typesetter, Cambridge Typesetters, Bethesda, Maryland, won an award for the October 1983 issue of OTA. Vawter reminded the membership that OTA is looking for new abstractors, especially those who command less common languages or have access to less readily available material. In particular, abstractors with a command of Japanese and access to Japanese materials are needed.

Robert Karris, O.F.M., gave the editor's report on CBQMS. Since the last meeting, six manuscripts have been handled; two were rejected, two are still being evaluated, and two are close to publication.

The business meeting adjourned at 5:07 P.M.
