# Report of the Fifty-Third General Meeting of the Catholic Biblical Association of America

The fifty-third meeting of the Catholic Biblical Association of America was held August 13-16, 1990, at the University of Notre Dame, Notre Dame, Indiana. John P. Meier, vice president of the association, introduced the president, Emil Wcela. Bishop Wcela recalled the memory of James Reese, O.S.F.S., elected president of the association for the current year, who died in December, 1989. The members stood in silent prayer in Fr. Reese's memory. Bishop Wcela then delivered the presidential address, "Who Do You Say That They Are? Reflections on the Biblical Audience Today."

Sessions on Wednesday, August 15

The task forces and continuing seminars resumed their work during the first part of the morning. Two simultaneous sessions then heard presentations by James C. VanderKam, "Joshua the High Priest and the Interpretation of Zechariah 3," and by Beverly R. Gaventa, "Disciple, Prophet, and Mother: Mary in Luke-Acts."

His Excellency John M. D'Arcy, Bishop of Fort Wayne-South Bend, was principal celebrant and homilist for the eucharistic liturgy at midday.

The general session in the afternoon listened to a panel discussion on "Biblical Scholarship Twenty-five Years after Vatican II." The moderator was John J. Collins, and the panelists were John R. Donahue, S.J., Marie-Eloise Rosenblatt, R.S.M., and Lawrence E. Boadt, C.S.P.

CBA President Emil Weela called the annual business meeting to order at 4:10 P.M. In the absence of Msgr. Myles Bourke, CBA executive secretary Joseph Jensen, O.S.B., gave the report of the chair of the Board of Trustees on the healthy financial situation of the association. Aloysius Fitzgerald, F.S.C., then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. He began by thanking the local arrangements committee for making this year's meeting pleasant and smooth. He then announced the grants that had been approved or reaffirmed by the Executive Board: (a) \$30,000 for ten stipends in the Memorial Stipends program; (b) \$20,000 plus travelling expenses for two fellowships in the Young Scholars' Fellowships program; (c) \$5,000 for the Elenchus of Biblica; (d) \$8,000 plus travel expenses for the Visiting Professorship at the Pontifical Biblical Institute (there was no appointment to the Ecole Biblique this year); (e) \$2,000 for the translation project of the Studium Biblicum Franciscanum; (f) \$2,587 (a tithe of membership dues) for famine relief; (g) \$6,000 for three archaeological research stipends; (h) \$5,500 for the archaeological dig at Tell Nimrin. He mentioned that the archaeological dig at Tell Qarqur is still on hold; the excavating team is attempting to raise enough money to supplement the CBA grant to get the project underway again. The Executive Board also voted to continue to supply the Religious Studies Review to members of the association who live in the U.S.A. The Board discussed a significant policy issue, namely, the "Catholic identity" of the Catholic Biblical Association. This is not a desire to define our "Catholic identity" in a narrowly confessional way, but somehow to claim and maintain a religious conviction and commitment as part of that identity: Scripture is the word of God, and our work is not based solely on academic considerations, but on a desire to understand and to share the riches of that divine word. It is important to have a Catholic Biblical Association—a group that can speak out of scholarly competence to the whole Church, bishops and laity alike. But without attention, as our organization attracts a more widely diverse membership, that identity could disappear by default. How do we preserve it? The Executive Board established a committee of several recent past presidents of the CBA to consider the issue. In other actions, the Executive Board also elected Raymond E. Brown, S.S., to the Board of Trustees and provided for rotation of membership on the Committee on Archaeological Evaluation. Jensen reminded the members that next year's meeting will be at Loyola Marymount College in Los Angeles, August 10-13, 1991; members should note that this inaugurates the shift approved by the membership from a mid-week meeting to a weekend. In 1992 the meeting will be held at The Catholic University of America in Washington, D.C., August 15-18. The projected dates for the 1993 meeting, August 14-17, should mesh conveniently with the dates for the meeting of the SNTS (August 9-13). Jensen reminded the members of the importance of soliciting invitations from our academic institutions; otherwise the favorable meeting arrangements we have enjoyed will be impossible to maintain.

John Kselman, S.S., gave the report of the editor of *CBQ*. In 1990, approximately 25 articles will have been published, covering 411 pages. Since last year, 99 mss were received, of which one has been published, 11 have been accepted, 56 were rejected, one was withdrawn, and 31 are still under consideration. Kselman announced that Bernard Batto has been appointed as OT book review editor, and he urged members to volunteer their services as reviewers. Those interested should submit resumés, along with information about language competency and areas of interest, either to Kselman or to the appropriate book review editor (OT: Batto; NT: Carolyn Osiek). Kselman also announced that it was decided to drop from the "Biblical News" section of *CBO* notices about publications by members.

Thomas McCreesh, O.P., gave the report of the editor of *OTA*. Delays are almost under control, and *OTA* should be on time in the near future. During 1990, between 120 and 130 books will have been abstracted; McCreesh hopes to raise this figure by 10 or 20 books in future volumes; around 970 periodical articles were abstracted. During this year, he has developed a series of written guidelines for abstractors, of whom *OTA* currently has about 45.

Robert Karris, O.F.M., reported as editor of the CBQMS. During 1990, 13 mss were examined, of which one was accepted, one was rejected, nine were not considered because they were unrevised dissertations, and 2 were not considered for various other reasons. Karris urged the members to consider the CBQMS as a vehicle for their own publications, and he thanked his editorial board for their continued work and cooperation.

Joseph Jensen, O.S.B., reported on the *NAB* Psalter revision. Most of the revisions had been received by the target date of January, 1989. Since April, 1989, the steering committee has met one weekend per month, trying to bring the work of the thirty revisers into stylistic unity. The committee finished a first review of all the psalms in April, 1990; this version was then produced as a book and sent to a committee of five bishops, from whom favorable responses were received. The steering committee is now going through the revision a second time, taking into account suggestions and comments of the bishops as well as of two specialists in English style who have examined the translations. At present, the committee is trying to produce a Psalter that uses inclusive language vertically (God-language) as well as horizontally (references to human beings). There is a set of guidelines on these issues developed by the bishops' committees on liturgy and on doctrine; there is some disagreement on whether all of the proposed revisions are fully in harmony with these guidelines. The steering committee's target date for completion of the Psalter is 1991, in order to have it ready for the new lectionary due to be produced in 1992.

The candidates were accepted by unanimous voice vote. In the absence of Sandra Schneiders, I.H.M., Neil McEleney, C.S.P., reported for the Committee on Nominations. The following slate of candidates was proposed: *President:* John P. Meier; *Vice President:* Richard J. Clifford, S.J.; *Executive Secretary:* Joseph Jensen, O.S.B.; *Treasurer:* Aloysius Fitzgerald, F.S.C.; *Consultors,* 1990-92: Dianne Bergant, C.S.A., and Charles Homer Giblin; *Chair of the Board of Trustees:* Myles M. Bourke; *Committee on Nominations,* 1990-94: Daniel J. Harrington, S.J.; *Associate Editors of the CBQ:* Aelred Cody, O.S.B.; Michael D. Coogan; James L. Crenshaw; Robert A. Di Vito; Julian V. Hills; Maurya P. Horgan; Kathleen M. O'Connor; Anthony J. Saldarini; and Charles H. Talbert. The membership elected the slate by unanimous voice vote.

For the Committee on Resolutions, James A. Fischer, C.M., proposed a resolution thanking the officials of the University of Notre Dame, the Local Arrangements and the Program Committees, and Bishop John M. D'Arcy for their respective contributions to making this meeting of the association so pleasant and successful. Fischer also proposed a resolution expressing the association's gratitude to Michael Glazier for his creative leadership in publishing in the area of biblical scholarship, and requesting that the association bring him and his family to the CBA meeting next year in Los Angeles to receive a tribute of gratitude from the membership. The

resolutions were approved by unanimous voice vote. Under new business, Benedict Viviano, O.P., rose to thank the CBA for its support of the 100th anniversary of the Ecole Biblique, and to read a letter of thanks to the association from Francis Moloney, the CBA Visiting Professor at the Ecole Biblique during the past year.

Roland Murphy, O.Carm., moved that: "At the next CBA meeting, the Executive Board, having looked into the possibility of a revision of the NAB Old Testament, report the results to the membership." After some discussion and after clarification of the limits on the CBA's authority in the matter, the motion was passed by unanimous voice vote.

A motion was introduced directing the Executive Board to look into the advisability of raising prices for dues, and for subscriptions to CBO, OTA, and CBOMS. After discussion, the motion was defeated by a show of hands of the membership.

A proposal was made that CBQMS look into more aggressive marketing practices; the proposal was referred to the editor of CBQMS.

The meeting was adjourned at 5:30 P.M.

The general session in the evening heard Philip J. King deliver the paper, "Jeremiah: An Archaeological Companion."
