# Report of the Fifty-Seventh General Meeting of the Catholic Biblical Association of America

The fifty-seventh meeting of the Catholic Biblical Association of America was held August 13-16, 1994, at the University of San Diego, San Diego, California. The opening general session was held on Saturday evening, August 13. Emil Wcela, Chair of the Board of Trustees, introduced John R. Donahue, S.J., president of the association, who delivered the presidential address, "Windows and Mirrors: The Setting of Mark's Gospel."

Irene Nowell, O.S.B., presided at our evening service of the word.

The evening general session featured a paper by Sean McEvenue, "Exegesis as Knowledge of Things Unseen."

Sessions on Monday, August 15

The task forces and continuing seminars resumed their work during the first part of the morning. Two simultaneous sessions then heard presentations by John S. Kselman, S.S., "Psalm 55: Problems and Proposals"; and Urban C. von Wahlde, "Some Observations on the Johannine High Christology and Its Gospel Context."

John R. Donahue, S.J., president of the association, was principal celebrant and homilist at our midday eucharistic liturgy.

The first part of the afternoon was devoted to four separate presentations of computer software of interest to biblicists. Members of the association's Computer Committee demonstrated basic software for the PC (Richard A. Edwards, Hugh M. Humphrey, and Jerome T. Walsh) and for the Apple (Gordon F. Davies), and more advanced software for the PC (Richard Jordan, James P. McIlhone, and Jean-Pierre Ruiz) and for the Apple (Alexander A. Di Lella, O.F.M.).

The CBA president John R. Donahue, S.J., called the annual business meeting to order at 4:03 P.M. Emil Weela gave the report of the chair of the Board of Trustees on the healthy financial situation of the association and on the board's plans to have an outside firm evaluate our investment practices. The board will also develop a statement of principles to be used in our investment practices. In the absence of Aloysius Fitzgerald, F.S.C., treasurer of the association, Joseph Jensen, O.S.B., executive secretary of the association, then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. He began by thanking those who had contributed to the success of this year's meeting, in particular the Local Arrangements Committee and the Program Committee. He announced that the Executive Board approved or reaffirmed the following grants: (a) \$20,000 plus travel expenses for the visiting professorships at the Pontifical Biblical Institute and the Ecole Biblique (John F. O'Grady and Terrence Prendergast, S.J., respectively, were chosen for these institutions for the 1994-95 academic year); (b) \$30,000 for the continuation of the Memorial Stipends program; (c) \$20,000 plus travel expenses for the continuation of the Young Scholars' Fellowship program; (d) \$6,000 for continuation of the archaeological research stipends program; (e) \$5,000 for the Elenchus of Biblica; (f) \$2,000 for the Japanese translation project of the Studium Biblicum Franciscanum; (g) \$3,915 (a tithe of membership dues) for famine relief; (h) \$16,000 for the archaeological project at Tell Qarqur; (i) \$10,000 for the archaeological project at Tell Nimrin. A renewed grant request from the Dead Sea Scrolls Foundation remains under consideration. The Executive Board also voted to continue to supply Religious Studies Review to members of the association who live in the U.S.A. and Canada, because of the advantageous price the association can get by buying the subscriptions in bulk. The Board considered a proposal to gather an oral history of the association; Carolyn Osiek, R.S.C.J., was named to form and chair a committee to organize the project. He announced that, after a discussion of the issues surrounding the question of inclusive language in translations of the Scriptures, the Board had passed the following resolution: "Be it resolved that the Executive Board of the Catholic Biblical Association of America at its Fifty-Seventh Annual Meeting (University of San Diego, August 13, 1994) supports and commends the NCCB on their Criteria for Evaluating Inclusive Language Translations of Scriptural Texts Proposed for Liturgical Use, as fostering legitimate representations of the original authors' intentions. The Board also encourages the NCCB to continue to instruct all Catholics in the appropriateness of inclusive language." The Board elected Anthony J. Tambasco to the Board of Trustees and appointed Thomas Schaub and Kathleen Nash, S.S.N.D., to the Archaeology Committee. Jensen reminded the members that the 1995 meeting will be held at Siena College, Loudonville, New York, August 12-15. The 1996 meeting will be at the University of St. Thomas, St. Paul, Minnesota; the dates will be August 10-13. Jensen urged members to solicit invitations for future meetings from their academic institutions.

Aelred Cody, O.S.B., gave the report of the editor of the *CBQ*. By the end of the current volume, the *CBQ* will have published approximately 26 articles. Seventy-eight articles were received in twelve months. Of these, one has been published (the presidential address), 18 have been accepted, 37 rejected, 21 are in process, and 1 was withdrawn. The unfortunate delay in the appearance of issues of *CBQ* is being corrected.

Christopher T. Begg gave the report of the editor of OTA. The first issue of 1994 contained 883 abstracts, of which 560 were of articles from journals, 111 were of books, and 212 were of articles in 15 Festschriften and collections. The second issue contained 737 abstracts, of which 452 were of articles from journals, 117 were of books, and 168 were of articles in 14 Festschriften and collections. The association has signed a contract with the American Theological Library Association to put Old Testament Abstracts on CD-ROM. Ultimately, OTA will also be available in MARC format and online.

Michael L. Barré, S.S., gave the report of the editor of the CBQMS. Two new volumes in the series are in press and will appear very soon. Two other manuscripts have recently been approved, one was rejected, one is under consideration, and one was returned as it was an unrevised dissertation. Other inquiries were received, but the manuscripts proved to be either unrevised dissertations, which the series does not publish, or too short for consideration.

Joseph Jensen, O.S.B., then reported on the status of the project to revise the NAB translation of the Old Testament. A steering committee has been formed, and scholars have been invited to undertake the revision of the various books. The CBA office is currently receiving replies to these invitations. Those who accept will be supplied with electronic and/or hard copies of their texts and will be asked to submit the revisions on the hard copy or in redline-strikeout form, so that the steering committee can easily see what changes have been made. Deadlines vary with the amount of material the scholar is revising.

For the Committee on Resolutions, James A. Fischer, C.M., proposed a resolution thanking the University of San Diego and the Local Arrangements Committee for their hospitality, and the publishers and purveyors of software for their displays. The resolution was approved by unanimous voice vote.

Under new business, Emil Wcela urged the membership to write, especially on a popular level and in irenic terms, to explain to the general public the importance of inclusive language in biblical translations.

The meeting was adjourned at 5:08 P.M.
