

Report of the Fifty-eighth General Meeting of the Catholic Biblical Association of America

The Fifty-eighth General Meeting of the Catholic Biblical Association of America was held at Siena College, Loudonville, New York, August 12–15, 1995. The opening general session was held on Saturday evening, August 12. Lawrence Boadt, C.S.P., vice-president of the association, introduced Michael B. Dick, who welcomed us in the name of Siena College. Carolyn A. Osiek, R.S.C.J., president of the association, then delivered the presidential address, “The Family in Early Christianity: ‘Family Values’ Revisited.”

Sessions on Sunday, August 15

Sessions on Monday, August 14

The task forces and continuing seminars resumed their work during the first part of the morning. Two simultaneous sessions then heard presentations by Irene Nowell, O.S.B., "Angels, Biblical, Patristic, and Modern," and Dennis Hamm, S.J., "God the Creator in Luke-Acts: Soundings in Theology from Below."

Shawn Carruth, O.S.B., presided at our midday service of the word.

The general session in the afternoon listened to a panel discussion on "Doing Biblical Theology Today." The moderator was Anthony J. Saldarini, and the panelists were Richard J. Clifford, S.J., John J. Collins, and Leo Lefebure.

Carolyn A. Osiek, R.S.C.J., president of the CBA, called the annual business meeting to order at 4:10 P.M. Emil Wcela gave the report of the chair of the Board of Trustees on the healthy financial situation of the association. Since last year the plan to have an outside firm review our investments and investment practices has been carried out. The next step is to develop a statement of the ethical and socially responsible guidelines to be followed in our investment practices. Aloysius Fitzgerald, F.S.C., treasurer of the association, then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. He thanked those who had contributed to the success of this year's meeting, in particular the Local Arrangements Committee and the Program Committee. The Executive Board approved or reaffirmed the following grants: (a) \$20,000 plus travel expenses for the visiting professorships at the Pontifical Biblical Institute and the Ecole Biblique, (b) \$30,000 for the continuation of the memorial stipends program, (c) \$20,000 plus travel expenses for the continuation of the young scholars' fellowship program, (d) \$6,000 for continuation of the archaeological research stipends program, (e) \$5,000 for the *Elenchus of Biblica*, (f) \$2,000 for the Japanese translation project of the Studium Biblicum Franciscanum, (g) \$3,983 (a tithe of membership dues) for famine relief, (h) \$16,000 for the archaeological project at Tell Qarqur, (i) \$15,000 for the archaeological project at Tell Nimrin, (j) \$2,000 for the Dead Sea Scrolls Foundation, (k) \$10,000 to the Ecole Biblique in Jerusalem toward the renovation of its library. The board also voted to continue to supply the *Religious Studies Review* to members of the association who live in the U.S.A. and Canada, because of the advantage

price the association can get by buying the subscriptions in bulk. The board also discussed ways to increase involvement of persons from the developing world in the association; a committee will be formed to consider the problem. The board elected Dianne Bergant, C.S.A., to the Board of Trustees and appointed Philip J. King to the Archaeology Committee. Alice L. Laffey was appointed chair of the Committee on Visiting Professors. Jensen reminded the members that the 1996 meeting will be at the University of St. Thomas, St. Paul, Minnesota; the dates will be August 10-13. The 1997 meeting will be at Seattle University, August 9-12. Jensen urged members to solicit invitations for future meetings from their academic institutions.

In the absence of Christopher T. Begg, Joseph Jensen, O.S.B., gave the report of the editor of *OTA*. The first issue of 1995 contained 615 abstracts, of which 305 were of articles from journals, 101 were of books, and 209 were of articles in festschrifts and collections. The second issue contained 673 abstracts, of which 361 were of articles from journals, 116 were of books, and 196 were of articles in festschrifts and collections.

In the absence of Michael L. Barré, S.S., Joseph Jensen, O.S.B., gave the report of the editor of the *CBQMS*. In the last year, three manuscripts have appeared in print, and one new volume in the series is in press and will appear very soon. One promising manuscript is being revised, one was withdrawn, and one was rejected. Other inquiries were received, but the manuscripts proved to be unrevised dissertations, which the series does not publish.

Joseph Jensen, O.S.B., then reported on the status of the project to revise the *NAB's* translation of the Old Testament. To date, nineteen partial or total manuscript revisions have been received by the editorial committee. The first round of editorial work consists of several steps; it has been completed for two of the books and is at various stages for the remainder. The steering committee meets one weekend each month. As an addendum to this report, Jensen reported to the membership on the resolution passed by the Executive Board last year regarding inclusive language in biblical translations for use in the liturgy, and on the conversations with the Congregation for the Doctrine of the Faith that have ensued.

Aelred Cody, O.S.B., gave the report of the editor of the *CBQ*. By the end of the current volume, *CBQ* will have published approximately 24 articles. Seventy-three articles were received in twelve months. Of these, one has been published (the presidential address), 13 have been accepted, 36 rejected, and 23 are in process.

Carolyn A. Osiek, R.S.C.J., president of the association, reported on the oral history project that was initiated at last year's meeting. The committee has selected a number of members whose participation in the association began before 1960, and it intends to interview them for anecdotal history about the early history of the association. To date, seven interviews have taken place. The committee is open to suggestions for other potential persons to be interviewed; the criteria are that they must have joined the association before 1960 and must have been active in it.

For the Committee on Resolutions, James A. Fischer, C.M., proposed a resolution thanking Siena College for their hospitality and the Local Arrangements Committee and all whose efforts made this year's meeting such a success. The resolution was approved by unanimous voice vote.
