Report of the Sixtieth General Meeting of the Catholic Biblical Association of America

The Sixtieth General Meeting of the Catholic Biblical Association of America was held August 9–12, 1997, at Seattle University, Seattle, Washington. The opening general session was held on Saturday evening, August 9. Donald P. Senior, C.P., vice-president of the association, introduced John J. Collins, president of the association, who then delivered the presidential address, "Natural Theology and Biblical Tradition: The Case of Hellenistic Judaism." After the address, the editor of CBQMS, Michael L. Barré, S.S., presented Roland E. Murphy, O.Carm., with the newest volume (no. 29) in the CBQMS, *Wisdom, You Are My Sister*, a festschrift honoring Murphy on the occasion of his eightieth birthday.

Sessions on Sunday, August 10

Sessions on Monday, August 11

The task forces and continuing seminars resumed their work during the first part of the morning. Two simultaneous sessions then heard presentations by Eugene C. Ulrich, "The Scriptures at the Time of Christ and *The Qumran Bible*"; and Douglas E. Oakman, "The Social Functionality of Money in the New Testament: Accursed Mammon or Money's Love."

Barbara Bowe, R.S.C.J., presided at our midday Service of the Word.

The general session in the afternoon listened to a panel discussion on "The Bible, Violence, and the Sacred." The moderator was Camilla Burns, S.N.D.deN., and the panelists were James G. Williams, Adela Yarbro Collins, and David W. Cotter, O.S.B.

John J. Collins, president of the association, called the annual business meeting to order at 4:10 P.M. Emil A. Weela gave the report of the chair of the board of trustees on the healthy financial situation of the association. The statement of guidelines to be followed in our investment practices has been completed and is available from the executive secretary. The board of trustees has decided to phase in gradually a policy of placing up to ten percent of our investments in special projects that promote economic justice and positive social change. Lawrence E. Boadt, C.S.P., treasurer of the association, then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. He thanked those who had contributed to the success of this year's meeting, in particular the local arrangements committee for the smooth running of the meeting, and the liturgy committee for the excellent services. The executive board approved or reaffirmed the following grants: (a) \$30,000 for ten memorial stipends, (b) \$20,000 for two young scholars' fellowships, (c) \$20,000 plus travel expenses for the visiting professors at the Pontifical Biblical Institute and the Ecole Biblique, (d) \$6,000 for three archaeological research stipends, (e) \$2,000 for the Japanese translation project of the Studium Biblicum Franciscanum, (f) \$3,976 (a tithe of membership dues) for famine relief, (g) \$17,500 for the archaeological project at Tell Qarqur, (h) \$10,000 for the archaeological project at Tell Mozan, (i) \$10,000 to the Ecole Biblique in Jerusalem toward the renovation of their library, (i) \$2,000 to the Dead Sea Scrolls Foundation, (k) \$3,000 in travel grants for third-world scholars to attend the CBA meeting, (1) \$5,000 to the Pontifical Biblical Institute in Jerusalem toward the renovation of their museum. The executive board also voted to continue to supply the Religious Studies Review to members of the association because of the advantageous price the association can get by buying the subscriptions in bulk. The board elected Anthony J. Saldarini to the board of trustees and appointed Richard J. Sklba to the archaeology committee. Jensen reminded the members that the 1998 meeting will be at the University of Scranton, Scranton, Pennsylvania; the dates will be August 8-11. The 1999 meeting will be at the University of Notre Dame, August 7-10. He announced that the supplement of the CBQ containing information about the members will be mailed out shortly, and that the website of the CBA includes general information about the association as well as about the membership. The OT revision of the New American Bible is continuing; the majority of the OT books have been completed. Finally, Jensen reported on the current status of the new lectionary.

In the absence of Christopher T. Begg, Joseph Jensen, O.S.B., gave the report of the editor of OTA. Both the February and the June issues of 1997 have appeared.

Michael L. Barré, S.S., gave the report of the editor of the CBQMS. In the last year, one manuscript has appeared in print, another is in press, a third has been approved for publication, and two others are in various stages of the process.

Aelred Cody, O.S.B., gave the report of the editor of the CBQ. By the end of the current volume, the CBQ will have published approximately twenty-four articles. Eighty-three articles were received in twelve months. Of these, fourteen have been accepted, forty-four rejected, twenty-four are in process, and one has been withdrawn. By the end of the current volume, the CBQ will have published approximately 255 reviews covering 262 books.

Under new business, the president, John J. Collins, announced that the executive board was proposing four persons for lifetime honorary memberships in the CBA: Carlo Cardinal Martini, Mother Kathryn Sullivan, R.S.C.J., Myles M. Bourke, and Roland E. Murphy, O.Carm. The members present approved these honorary nominations by unanimous voice vote.

The meeting was adjourned at 4:46 P.M.
