

Report of the Sixty-third International Meeting of the Catholic Biblical Association of America

The Sixty-third International Meeting of the Catholic Biblical Association of America was held August 5–8, 2000, at Loyola Marymount University, Los Angeles, California. The opening general session was held on Saturday evening, August 5. Dianne Bergant, C.S.A., vice-president of the association, introduced Robert Lawton, S.J., president of Loyola Marymount University, who warmly welcomed the members of the association. Charles H. Talbert, president of the association, then

delivered the presidential address, "Paul, Judaism, and the Revisionists." After the presidential address, the president-elect, Dianne Bergant, asked the members to remain for a special presentation ceremony. Lawrence Boadt, C.S.P. then came forward in the name of the association to present Joseph Jensen, O.S.B., with a special citation and plaque in Latin for his thirty years of leadership and guidance as the executive secretary of the association. After a few words of tribute to the many accomplishments of Fr. Jensen over the years, he read to the assembled members the words of the citation, whose Latin text had been prepared by James Walsh, S.J., and he presented Fr. Jensen with the plaque, to the applause of appreciation from all. The citation reads, in English translation: "With the attainment of thirty years now, during which he has diligently attended to the interpretation, translation, and cultivation of God's word, his colleagues offer to Joseph Jensen, O.S.B., heartfelt congratulations, in the city of Los Angeles, on the Transfiguration of Our Lord Jesus Christ."

Sessions on Sunday, August 6

Sessions on Monday, August 7

The task forces and continuing seminars resumed their work in the morning. Two simultaneous sessions then heard presentations by Daniel J. Harrington, S.J., "The Old Testament Apocrypha in the Canon Debate," and S. Scott Bartchy, "Who Should Be Called 'Father'? Paul of Tarsus between the Jesus-Tradition and *Patria Potestas*."

Stephen B. Reid presided and preached at our midday prayer.

The general session in the afternoon listened to a panel discussion of "The Bible and Justice: Allies or Enemies?" The moderator was John L. White, and the panelists were Dennis Hamm, S.J., Gina Hens-Piazza, and Jean-Pierre Ruiz.

Charles H. Talbert, president of the CBA, called the annual business meeting to order at 4:05 P.M. Emil A. Wcela gave the report of the chair of the Board of Trustees on the healthy financial situation of the association. He reminded the members that the guidelines used for investing the association's assets include the production of an income stream to support the ongoing work of the association, especially the numerous grants that the association makes annually to scholarly projects. In accord with a policy announced in the past, the association places 10 percent of its investments in special projects that promote economic justice and positive social change. Lawrence E. Boadt, C.S.P., treasurer of the association, then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. He thanked all who had contributed to the success of this year's meeting, in particular the Local Arrangements Committee, the Program Committee, and the Liturgy Committee. The Executive Board approved or reaffirmed the following grants: (a) \$30,000 for ten memorial stipends; (b) \$40,000 for two Young Scholars' Fellowships (the fellowships were increased from \$10,000 to \$20,000 each); (c) \$18,000 for the dig at Tell Mozan; (d) \$40,000 plus travel expenses for the visiting professorships at the Pontifical Biblical Institute in Rome and the Ecole Biblique in Jerusalem (the stipends for the professorships were increased from \$10,000 to \$20,000 each); (e) \$9,000 for three archaeological research stipends (the stipends were increased from \$2,000 to \$3,000 each); (f) \$2,000 for the Japanese translation project of the Studium Biblicum Franciscanum in Tokyo; (g) a tithe of membership dues for famine relief; (h) \$18,000 for the archaeological project at Tell Qarqur; (i) \$10,000 to the Ecole Biblique toward the renovation of their library. The Executive Board also voted to continue three other commitments: to subsidize travel to the CBA meeting for a scholar from the developing world, to fund one CBA scholarship each to three institutions that offer a doctoral program in biblical studies (the Graduate Theological Union, the Catholic University of America, and Notre Dame University), and to supply the *Religious Studies Review* to members of the association. In addition, the board agreed to contribute \$5,000 as partial subsidy for a volume that will collect all recent Roman

documents on the study of Scripture. The book is to be edited by Dean P. Béchar, S.J., and published by Liturgical Press. A request was received from Leila Badre for funds to subsidize publication of the materials and results of excavations of a site in Beirut. The board agreed to contribute \$5,000 to this project. Jensen also announced that the October 2000 issue of the *CBQ* will be dedicated to Joseph A. Fitzmyer, S.J., in recognition of his many years of service to the CBA. The Executive Board elected George T. Montague, S.M., to the Board of Trustees and appointed Paula McNutt to the Archaeology Committee. Jensen reminded the members that the meeting in the year 2001 will be at Seton Hall University, South Orange, New Jersey; the dates will be August 4-7. The meeting in the year 2002 will be at John Carroll University, Cleveland, Ohio, August 3-6. Jensen informed the members that in the future, in addition to the costs of board and room, there will be a modest registration fee that will go to the hosting institution. Jensen announced that the CBA will be involved in a project with the American Theological Library Association (ATLA). The ATLA has received a grant of \$4,000,000 from the Lilly Foundation to make the fifty most important theological journals available in electronic form, beginning with the volumes of 1946. One of those journals is the *CBQ*. The CBA will benefit from sales of the product. The CBA webpage has been redesigned, and it has a new URL: <http://cba.cua.edu>. Included on the webpage are a membership directory containing all the information in the published supplement to *CBQ* (updated monthly) and a telephone or linked e-mail directory (updated daily). Jensen asked the members to check their personal information in these directories and to inform the office of the CBA if there are errors or omissions. The Computer Committee has suggestions that would make the webpage even more useful. Finally, Jensen informed the members that the project to revise the OT of the *New American Bible* is close to completion; almost all of the material has been examined carefully at least once.

Aelred Cody, O.S.B., gave the report of the editor of the *CBQ*. By the end of the current volume, the *CBQ* will have published approximately 27 articles. In twelve months, 75 articles were received. Of these, 18 have been accepted, 34 rejected; 23 are in process. By the end of the current volume, the *CBQ* will have published approximately 238 reviews covering 244 books. The editorial board of the *CBQ* has elected Richard Dillon the new general editor, to begin January 1, 2001.

In the absence of Christopher T. Begg, Joseph Jensen, O.S.B., gave the report of the editor of *OTA*. Both the February and June issues of 2000 have appeared, and the October issue is at the typesetter's. The first two issues of the year have published abstracts of 1,164 articles and 227 books.

In the absence of Mark S. Smith, Joseph Jensen, O.S.B., gave the report of the editor of the *CBQMS*. In the last year, four manuscripts were received, of which one was accepted and is being revised, one is under review, one was found to be inappropriate for the series, and one was rejected. One further manuscript, received in a previous year, is still under review. Smith expressed his gratitude to the previous editor, Michael L. Barré, S.S., for the smoothness of the transition to a new editor.

The members elected those on this slate by unanimous voice vote.

For the Committee on Resolutions, James A. Fischer, C.M., proposed a resolution thanking the Rev. Robert Lawton, S.J., president of Loyola Marymount University, and his staff for their hospitality, and thanking the Local Arrangements Committee, the Program Committee, the Liturgy Committee, and all whose efforts made this year's meeting such a success. For the editorial board of the *CBQ*, Gregory E. Sterling proposed the following resolution: "Whereas Aelred Cody, O.S.B., has served the Catholic Biblical Association of America as general editor of *The Catholic Biblical Quarterly* for eight years, and whereas he has maintained the high professional standards of the journal, and whereas he has done so in a spirit of selflessness and generosity, be it resolved that we, the members of the CBA, express our deep gratitude through a moment of recognition and a hearty round of applause." The resolutions were approved by spontaneous applause by the members.

The meeting was adjourned at 5:00 P.M.
