Report of the Sixty-Fifth International Meeting of the Catholic Biblical Association of America

The sixty-fifth international meeting of the Catholic Biblical Association of America was held August 3–6, 2002, at John Carroll University, University Heights, Ohio. The opening general session was held on Saturday evening, August 3rd. Eugene C. Ulrich, vice-president of the association, announced the sad news of the death of Roland E. Murphy, O.Carm., on July 20, 2002. The membership stood for a moment of silent prayer in tribute to this former president of the CBA. Ulrich then introduced the Reverend Edward Glynn, S.J., president of John Carroll University, who warmly welcomed the members of the association. Francis J. Moloney, S.D.B., president of the association, then delivered the presidential address, "Raymond Brown's New Introduction to the Gospel of John: A Presentation and Some Questions."

Sessions on Monday, August 6

The task forces and continuing seminars resumed their work in the morning. Two simultaneous sessions then heard presentations by Toni Craven, "Fearfully Funny: Some Instances in the Deuterocanonical Books," and John P. Meier, "The Historical Jesus and the Historical Law: Problems within the Problem."

Dianne Bergant, C.S.A., presided and preached at our midday prayer.

The general session in the afternoon listened to a panel discussion on "Interpreting the Jewish Bible in the Christian Bible: A Discussion of the PBC's Document, *The Jewish People and Their Sacred Scripture in the Christian Bible.*" The moderator was John R. Donahue, S.J., and the panelists were Donald P. Senior, C.P., Lawrence E. Frizzell, and Amy-Jill Levine.

CBA president Francis Moloney, S.D.B., called the annual business meeting to order at 4:10 p.m. Richard J. Sklba gave the report of the chair of the Board of Trustees on the financial situation of the association. Given the recent market slump, and the fact that our program of grants has continued without stint, there has been a decrease in the Association's portfolio of approximately 8% (compared to a decrease in the S&P index of 17% during the same period). The Board continues to implement the Association's policy of placing up to ten percent of its investments in special projects that promote economic justice and positive social change. Lawrence E. Boadt, C.S.P., treasurer of the association, then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. He thanked all who had contributed to the success of this year's meeting, in particular the Local Arrangements Committee, the Program Committee, and the Liturgy Committee, and the president of John Carroll University, the Reverend Edward Glynn, S.J. The Executive Board approved or reaffirmed the following grants: (a) \$30,000 for ten Memorial Stipends; (b) \$40,000 for two CBA Fellowships; (c) \$17,000 for the archaeological project at Tell Qarqur; (d) \$18,000 for the dig at Tell Mozan/Urkesh; (e) \$40,000 plus travel expenses for the Visiting Professorships at the Pontifical Biblical Institute and the Ecole Biblique; (f) \$9,000 for three archaeological research stipends; (g) \$2,000 for the Japanese translation project of the Studium Biblicum Franciscanum; (h) a tithe of membership dues (\$4,163) for famine relief; (i) \$10,000 to the Ecole Biblique in Jerusalem toward the renovation of the library; (j) \$5,000 to the Dead Sea Scrolls Foundation; (k) three CBA scholarships at institutions with doctoral programs in biblical studies. The Board also voted to continue to subscribe to Religious Studies Review for members of the association. New guidelines have been approved for the CBQMS; these will be posted on the CBA website. The Board elected Michael Barré, S.S., to the Board of Trustees, and voted to nominate Joseph Blenkinsopp for the Committee on Nominations. Jensen informed the members that the NAB Old Testament revision has been completed. The results are now in the hands of the USCCB, which has sent them to censors for evaluation. A membership supplement to the CBQ is

in process, and should be completed later this year. Next year's meeting will be held at the University of San Francisco, August 2-5, 2003. The venue for the 2004 meeting was delayed for discussion under "New Business." All subscribers to CBQ and members of the CBA now have access to fifty years of back issues through the CBA website. The member's customer number functions as the password.

Richard J. Dillon gave the report of the editor of the CBQ. Due to the generous volunteering of Joseph A. Fitzmyer, S.J., Dillon hopes to eliminate the lateness that is plaguing the journal and get all 2002 issues out by the end of the calendar year. This means that the backlog of articles will be almost entirely used up. Members are urged to submit and to solicit from others articles for the CBQ, knowing that the wait time between final acceptance and appearance in print will be quite short. By the end of the current volume, CBQ will have published approximately 26 articles. Fifty-seven articles were received in twelve months. Of these, 11 have been accepted. By the July, 2002, issue, CBQ will have published approximately 239 book reviews. Dillon informed the members that the editorial board has drawn up a procedure for the selection of future editors of CBQ; this procedure will be submitted to the membership for its consideration in the future.

In the absence of Christopher T. Begg, Joseph Jensen, O.S.B., gave the report of the editor of OTA. Both the February and July 2002 issues have appeared and the October issue is at the typesetter. The first two issues of the year have published 1,313 article abstracts, 222 book abstracts, and 2 computer software abstracts. OTA made the move to its new quarters in Caldwell Hall on the campus of Catholic University at the beginning of July 2002, with a minimal disruption of operations. OTA business of all kinds is increasingly being done by email. With the death of Roland Murphy, OTA lost its all-time champion abstractor. R.I.P.

Mark S. Smith gave the report of the editor of CBQMS. One volume, which was in press at the time of last year's meeting, has appeared, and two more volumes appeared this year as well. One further volume is in press, another has been accepted for publication, one has been submitted for evaluation, and six queries have been received about works in progress. Updated guidelines for the series have been submitted to the Executive Board and will be posted on the CBA website. Smith urged the members to submit manuscripts for consideration, particularly in New Testament studies.

After some discussion, the membership chose the offer from St. Mary's University, Halifax, Nova Scotia, Canada.
