Report of the Sixty-seventh International Meeting of the Catholic Biblical Association of America

The sixty-seventh international meeting of the Catholic Biblical Association of America was held August 7–10, 2004, at St. Mary's University, Halifax, Nova Scotia. The opening general session was held on Saturday evening, August 7th. Aelred Cody, O.S.B., vice-president of the association, introduced Frank J. Matera, president of the association, who delivered the presidential address, "New Testament Theology: History, Method, and Identity."

Sessions on Sunday, August 8

Sunday evening's general session featured a paper by Marc Girard, "The Impact of Biblical Symbolism on Certain Current Issues in Theology and Pastoral Life." At the end of the session, Jeremy Corley and Vincent Skemp invited Alexander Di Lella, O.F.M., forward and presented him with an advance copy of a festschrift that they had edited in honor of his 75th birthday entitled *Intertextual Studies in Ben Sira and Tobit: Essays in Honor of Alexander A. Di Lella, O.F.M.* It will be published as CBQMS 38.

Sessions on Monday, August 9

The task forces and continuing seminars resumed their work in the morning. Two simultaneous sessions then featured presentations by Pauline A. Viviano, "Jeremiah's Temple Sermon: A Literary Analysis"; and Mary L. Coloe, P.B.V.M., "The Footwashing as Welcome: John 13."

The general session in the afternoon listened to a panel discussion on "The Bible and Political Discourse." The moderator was Archbishop Terrence T. Prendergast, S.J., and the panelists were Warren Carter, Alice L. Laffey, and Leo Lefebure.

CBA president Frank J. Matera called the annual business meeting to order at 4:05 P.M. Richard J. Sklba gave the report of the chair of the Board of Trustees on the healthy financial situation of the association. Lawrence E. Boadt, C.S.P., treasurer of the association, then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. The Executive Board approved or reaffirmed the following grants: (a) \$48,000 for twelve Memorial Stipends (this involves an additional two stipends and an additional \$1,000 per stipend; (b) \$40,000 for two CBA Fellowships; (c) \$18,000 for the dig at Tell Mozan/Urkesh; (d) \$40,000 plus travel expenses for the Visiting Professorships at the Pontifical Biblical Institute and the Ecole Biblique; (e) \$9,000 for three archaeological research stipends; (f)\$2,500 for the Japanese translation project of the Studium Biblicum Franciscanum; (g) a tithe of membership dues for famine relief (\$5,347); (h) \$20,000 for the archaeological project at Tell Qarqur; (i) \$10,000 to the Ecole Biblique in Jerusalem toward the renovation of the library; (j) \$5,000 to the Dead Sea Scrolls Foundation; (k) four CBA scholarships at institutions with doctoral programs in biblical studies; (1) funds for travel grants. The Board also voted to continue to supply the Religious Studies Review to members of the association. The Board elected Pauline Viviano to the Board of Trustees, nominated Frank J. Matera for the Committee on Nominations, and appointed John R. Donahue, S.J., to the Committee Memorial Stipends and CBA Fellowships. Jensen informed the members that although the NAB Old Testament revision was completed in May 2002, it is still undergoing a process of review by censors, which has to be completed before it can be presented to the bishops for approval. The new printed membership directory of the association is planned for next year, and Jensen urged members to review their entries on the CBA web page and to send in timely updated information, as indicated there. He also urged members to provide e-mail addresses, at least for our listserv, preferably also for the web directory. Next year's meeting will be held at St. John's University, Collegeville, MN, August 6-9, 2005, and the meeting of the following year at Loyola University, Chicago, August 5-8, 2006. The 2007 meeting should be held on the West Coast, but since no invitations have been received from West Coast institutions for 2007, the invitation from Fordham University, originally earmarked for 2008, may be utilized for 2007.

Richard J. Dillon gave the report of the editor of the *CBQ*. The increased selectivity of the manuscript assessments by associate editors has pared the backlog of articles slated for publication. As a result, individual issues of the journal are featuring five articles instead of six or seven, and page totals are down closer to one hundred fifty than to the standard two hundred pages of past years. Should the backlog of articles increase, the size of the journal may grow as well. A committee was appointed last year to develop a more precise job description of the general editor and to nominate a successor to Dillon, who will conclude four years in the position on December 31, 2004. The nominating committee, under Francis J. Moloney, S.D.B., as chair, presented Linda M. Day, currently an associate editor, as its nominee; and the nomination was ratified by majority vote of the *CBQ* editorial board. Dr. Day will assume the position of general editor on January 1, 2005. As for the annual statistical report: during 2003, 22 articles were published; 83 manuscripts were received, of which 16 have been accepted, 52 rejected, and 15 remain in process; and 214 book reviews will have appeared in volume 66 (2004).

In the absence of Christopher T. Begg, Joseph Jensen, O.S.B., gave the report of the editor of *OTA*. Both the February and July 2004 issues have appeared, and the October issue is in process. The first two issues of the year have published 1,296 article abstracts and 255 book abstracts. During 2004, one new journal exchange was initiated. Jensen reported that negotiations involving ATLA, CBA, and Ebsco aimed at placing the total run of *OTA* on line continue on schedule; this is in addition to the CD-ROMs that have been available now for several years.

Mark S. Smith gave the report of the editor of CBQMS. Volumes 36 and 37 have appeared, and volumes 38 and 39 are in preparation. Three manuscripts were submitted this year and one accepted. Smith urged the members to submit manuscripts for consideration, particularly in New Testament studies.
