# Report of the Sixty-ninth International Meeting of the Catholic Biblical Association of America

The sixty-ninth international meeting of the Catholic Biblical Association of America was held August 5–8, 2006, at Loyola University, Chicago, Illinois. The opening general session was held on Saturday evening, August 5. In the name of the president of the university, the vice-president for mission and ministry, Dr. Lucien Roy, warmly greeted the members of the association. Irene Nowell, O.S.B., vice-president of the association, then introduced John C. Endres, S.J., president of the association, who delivered the presidential address, "The Spiritual Vision of Chronicles: Whole-hearted, Joy-filled Worship of God."

#### Sessions on Monday, August 7

The task forces and continuing seminars resumed their work in the morning. Two simultaneous sessions then heard presentations by Mark S. Smith, "Lost in Translation? Translatability of Divinity across Cultures in Israel and the Ancient Near East"; and Bruce J. Malina, "Social Science Interpretation of the New Testament: Acquisitions and Prospects."

Regina Plunkett-Dowling presided and preached at the midday prayer service.

The general session in the afternoon listened to a panel discussion on "The Bible and Film." The moderator was Corrine Carvalho and the panelists were John W. Martens and Kim Paffenroth.

CBA president John C. Endres, S.J., called the annual business meeting to order at 4:08 P.M. Richard J. Sklba gave the report of the chair of the Board of Trustees on the healthy financial situation of the association. Lawrence E. Boadt, C.S.P., treasurer of the association, then presented the treasurer's report, the substance of which had been previously distributed to the members present.

Joseph Jensen, O.S.B., gave the report of the executive secretary. The Executive Board approved or reaffirmed the following grants: (a) \$48,000 for twelve Memorial Stipends; (b) \$40,000 plus travel expenses for two CBA Fellowships; (c) \$16,000 for the dig at Tell Mozan/Urkesh; (d) \$40,000 plus travel expenses for the Visiting Professorships at the Pontifical Biblical Institute and the Ecole Biblique; (e) \$9,000 for three archaeological research stipends; (f) \$2,500 for the Japanese translation project of the Studium Biblicum Franciscanum; (g) \$17,742, a tithe of the association's surplus for famine relief; (h) \$26,000 for the archaeological project at Tell Qarqur; (i) \$10,000 to the Ecole Biblique in Jerusalem toward the renovation of their library; (j) \$5,000 to the Dead Sea Scrolls Foundation; (k) four CBA scholarships at institutions with doctoral programs in biblical studies; (l) \$3,000 budgeted for travel grants to our annual meeting. The Board also voted to continue to pay for subscriptions to the *Religious Studies Review* for members of the association.

The CBA Fellowships were awarded to Angela Kim Harkins and Christine Yoder. The CBA Visiting Professorships were awarded to Michael Dick (to the PBI) and to Michel Gourges (to the Ecole Biblique).

The Board voted to propose Norbert Lohfink, S.J., and Robert North, S.J., as honorary life members of the CBA. It also nominated Richard J. Sklba for a new term as chair of the Board of Trustees, Harold W. Attridge as a member of that Board, and John C. Endres, S.J., for the Committee on Nominations.

Jensen briefly reviewed the history of the NAB OT revision project and reported that the revision committee finished their work and submitted it to the USCCB in May 2002. Since that time, the bishops' Ad Hoc Committee for Scripture Translations has sent comments on the translation of fourteen books, and the CBA revision committee has responded to those comments. It is said that the revision is planned to be ready for final approval by March 2007. The revised NAB Psalter, completed and approved in 1991, has undergone two unofficial revisions to adapt it more successfully to liturgical norms and practice. These revisions are available for consultation, with their respective rationales, on the CBA website.

The association will meet next year at Santa Clara University (August 4–7, 2007) and the year following at Fordham University (August 2–5, 2008).

Linda Day gave the report of the editor of the CBQ. She began by expressing appreciation for the work of the associate editors of the journal, and in particular those whose terms as associate editor were expiring this year: Beverly R. Gaventa; Gina Hens-Piazza; Leslie J. Hoppe, O.F.M.; and Peter Machinist. The number and quality of articles submitted this year were both quite high, and more articles have been accepted than in past years: eighty-three submissions were received, of which twenty-four have been accepted to date. As a result, there is a healthy, though not problematic, backlog of articles awaiting publication. By the October 2006 issue, the CBQ will have published 216 book reviews.

In the absence of Christopher T. Begg, Joseph Jensen, O.S.B., gave the report of the editor of *OTA*. Both the February and July 2002, issues have appeared and the October issue is in process. The first two issues of the year have published 676 article abstracts, 115 book abstracts, and one abstract of computer software.

Mark S. Smith gave the report of the editor of CBQMS. Volume 40 has appeared, and volumes 41–43 are in process. One manuscript was submitted but not accepted.

The membership approved the resolution by unanimous voice vote.
