Report of the Seventy-fifth International Meeting of the Catholic Biblical Association of America

The seventy-fifth international meeting of the Catholic Biblical Association of America was held July 28–31, 2012, at the University of Notre Dame, Notre Dame, Indiana. The opening general session was held on Saturday evening, July 28. Richard J. Dillon, Vice-President of the association, with the assistance of Gregory E. Sterling, introduced Harold W. Attridge, Jr., President of the association, who delivered the presidential address, "How Priestly Is the 'High Priestly' Prayer of John 17?"

Sessions on Sunday, July 29

Five task forces and eight continuing seminars met simultaneously each day from 9:00 to 10:45 A.M. The Most Reverend Kevin C. Rhoades, bishop of the Diocese of Fort Wayne-South Bend, was presider and homilist at the eucharistic liturgy at midday. Branick, "Universal Salvation in the Letters of Paul"; Angela Kim Harkins, "The Phenomenal Experience of Transformation in the Odes of Solomon 11"; Michael U. Udoekpo, "Psalm 126 and the Prophecy of Zephaniah: A Comparative Study"; William S. Morrow, "Legal Ambiguities"; Brigid Curtin Frein, "Jesus as Provocateur in Luke's Gospel"; Andrew T. Glicksman, "Divine Filiation in the Wisdom of Solomon"; Robert L. Mowery, "Fishers, Initiates, and Roman Christians"; Henry Ansgar Kelly, "Reclaiming the Middle English Bible from the Wycliffites."

In late afternoon a panel celebrating seventy-five years of the CBA was held. Members of the panel included Stephen Breck Reid, Frank J. Matera, Tom Stegner, S.J. (as proxy for Daniel J. Harrington, S.J.), and Sandra M. Schneiders, I.H.M., each of whom gave reflections on the CBA, followed by responses from the audience. Sheila E. McGinn served as the moderator. A banquet (generously provided by Notre Dame) followed, during which several presentations were made celebrating the life, work, and contributions of the outgoing Executive Secretary, Joseph Jensen, O.S.B., who served from 1970 to 2012. Harry Attridge introduced the program, noting the contributions of Joe Jensen and of the CBA Administrative Assistant, Maria Nazarczuk, and Mark S. Smith presented an encomium [included in full below]. A standing ovation was given to Joe Jensen. The banquet also included a presentation marking the CBA's anniversary year by Amy-Jill Levine with "choir," which added a touch of hilarity to the evening.

The general session in the evening consisted of a presentation from the Strategic Planning Committee (Michael Patella, O.S.B., chair; Harold W. Attridge; Dianne Bergant, C.S.A.; Corrine Carvalho; Amy-Jill Levine; John L. McLaughlin; Harry P. Nasuti; and Anathea E. Portier-Young) reporting the substance of its final report to the Executive Board. The committee offered several thematic topics that have governed its deliberations throughout its work, including mission and identity, membership, annual meetings, publications, technology and outreach, finances, and organization and administration. Since some of the recommendations would involve changes to the CBA Constitution and By-laws, the report included a version of these documents with tracked changes as well as a clean version of the amended documents. The Executive Board will consider any possible modifications to

the Constitution and By-laws and submit them to the membership for ratification at the 2013 annual meeting. The committee also recommends that, following the presentation of the substance of their report to the membership, the report be circulated to the membership electronically and posted on the Web site.

At the social hour Greg Sterling, the chair of the Committee on Local Arrangements, greeted the members of the CBA and gave everyone a warm welcome to the campus.

Sessions on Monday, July 30

Gerard S. Sloyan was the principal celebrant and homilist at the 7:00 A.M. eucharistic liturgy.

CBA President Harry Attridge called the annual business meeting to order at 4:00 P.M. He began by giving an introduction to family members of Bishop O'Hara, the founder of the CBA. In the absence of Daniel Harrington, S.J., Joseph Jensen, O.S.B., gave the report of the chair of the Board of Trustees.

Stephen D. Ryan, O.P., gave the Treasurer's report. There is a net balance of \$1,133,339.00, largely due to the USCCB grant for *NAB* royalties. He drew attention to the royalties of \$60,661.53 that our journals are bringing in and noted that OTA is making money. Overall income is down a bit. The transition to the new Web site is almost complete. He informed the members that they could see himself, Jensen, or Violet Halton (the CBA bookkeeper) for any detailed questions on the distributed report.

The Executive Secretary's report was given by Joseph Jensen, O.S.B. He gave thanks to God for the meeting at Notre Dame as well as for the settlement of the NAB royalties, and expressed gratitude to Greg Sterling and all who were involved in the local arrangements for the meeting. Ten percent of membership dues will be donated for famine relief. Jensen reviewed the settlement with the USCCB with regard to the payment of back royalties for

the next four years. There was discussion about hiring auditors for financial review. Honorary life membership was bestowed on Jensen and Linda Day, Joseph Atkinson will be replacing Jensen on the Board of Trustees. The 2013 annual meeting will be held August 3-6 at Gonzaga College in Spokane, Washington. The 2014 annual meeting will possibly be held at Providence College, Rhode Island, July 26-29. Atkinson will put together a committee to develop a long-term plan for annual meeting sites. A formal motion was made to have the new Executive Secretary replace Jensen on all financial accounts.

Linda Day gave the report of the General Editor of the CBQ. We continue to receive increasing numbers of submissions. There is concern among the editorial board about the poor quality of material sent by students. The search committee successfully completed two searches, resulting in the selection of Leslie Hoppe as the next General Editor and Linda Maloney as the next New Testament Book Review Editor. Day expressed gratitude to those persons completing their terms of service: Amy-Jill Levine, Mary Ann Beavis, Clift Black, David Carr, Sheila McGinn, David Penchansky.

In the absence of Christopher T. Begg, Jensen gave the report of the General Editor of OTA. He noted that two issues were produced, in February and June.

Mark Smith gave the report of the CBQMS. He announced that Rob Kugler will be the incoming chairperson and that four new editorial board members have been named: Kelley Coblentz Bautch, Mary Rose D'Angelo, Beverly Gaventa, and Amy-Jill Levine. We mourn the loss of Frederick Danker, who served the series excellently. Smith noted the publication of the two most recent monographs: CBQMS 48, Celebrating Paul: Festschrift in Honor of Jerome Murphy-O'Connor and Joseph A. Fitzmyer (edited by Peter Spitaler), and CBQMS 49, The Ancient Hebrew Semantic Field of Cutting Tools: A Philological, Archaeological, and Semantic Study, by Aaron Koller. CBQMS 50 will be a volume on Luke by Richard Dillon.

Ronald Witherup gave the report of the Committee on Resolutions, indicating resolutions of gratitude to the University of Notre Dame and Greg Sterling for their efforts toward a successful annual meeting, and to Joe Jenson for his years of service.

In new business, Felix Just, S.J., demonstrated new features of the Web site. It was decided that the final report of the Strategic Planning Committee be posted on the site in two versions, a standard version and another showing tracked changes. The incoming President will appoint an ad hoc committee to collect and address recommendations from the general membership regarding the proposed changes to the association and its governing documents. The Executive Board will determine the procedural processes by which the changes will be reviewed and presented to the membership. Attridge noted that a cordial letter from Cardinal Dolan, President of the USCCB, was received, congratulating the CBA on its 75th anniversary. This letter will be posted on the Web site. The Catholic Biblical Federation thanked the CBA for initiating a continuing seminar on Verbum Domini in preparation for the upcoming synod on evangelism.

The meeting was adjourned at 5:15 P.M.
