Candidates for membership must be sponsored by a Full Member of the association and are admitted after a vote by the membership at the Annual General Meeting.

FULL MEMBER

Qualification Criteria: Those who have an advanced research degree in Sacred Scripture or biblical theology, including the Ph.D., Th.D., S.T.D., S.S.L., or S.S.D.

ASSOCIATE MEMBER

Qualification Criteria: Those who are engaged in or have completed post-baccalaureate studies in biblical or allied fields or have taught Sacred Scripture for at least one year at the major-seminary or college level.

GRADUATE STUDENT MEMBER

Qualification Criteria: Those who are engaged in post-baccalaureate studies in biblical or allied fields.

Annual General Meeting

CBA has been meeting since 1936. It is an opportunity for scholars to share research, network, and socialize.

Full Members may present research papers during the AGM and vote during the Business Meeting.

Funding Opportunities

Research Grants

CBA seeks to promote Biblical Scholarship by providing financial assistance for specific projects advancing these goals. Accordingly, CBA Full Members may apply for the Grants from the CBA awarded annually (typically between \$2,000 - \$15,000).

CBA's Verbum Emerging Scholars Fellowship

Annually CBA, in partnership with Verbum, awards 4 Fellowships to promising graduate students to attend the Annual General Meeting to present their scholarship and enjoy the company and conversation of scholars in the field.

Doctoral Dissertation Stipends

Each year the CBA will award up to five stipends of \$5,000 each to doctoral candidates (Ph.D, Th.D., S.T.D.) who are engaged in writing their dissertations.

Archaeological Fellowship

CBA funds up to two fellowship awards annually of up to \$5,000 each to support CBA Full or Associate Member participation in an archaeological excavation.

Visiting Professorships

CBA Full Members may apply for either of the two offered Visiting Professorships:

- *École biblique et archéologique française de Jérusalem* (EBAF)
- *Pontificio Istituto Biblico*, Rome (PBI)

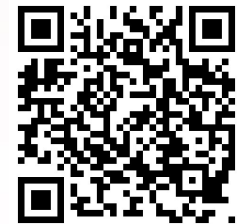
Tenure-track or tenured scholars of the CBA will have the opportunity to teach one course to an international cohort of students, equivalent to a doctoral/licentiate level course and to avail themselves of the resources of these venerable institutions.

Sabbatical Fellowship

One award of \$40,000 is granted annually to a CBA Full Member. This sabbatical fellowship is designed for individual researchers.

Travel Grants

CBA awards up to twelve \$900 grants to support the travel to attend the CBA Annual General Meeting.
