Kansas Legislative and Policy Report

2025 Pre-Session Memo

January 13, 2025

Overview

Community Bankers

The 2025 Session began today (Monday). Our December report included leadership elections and committee assignments, and we want to provide a brief memo to serve as a quick guide for what to expect as lawmakers return to Topeka next week. A few key points to keep in mind:

- The Session calendar is notably shorter than usual, with legislative leadership committed to adhering to a true 90-day Session, with the following key dates:
 - Turnaround, or the official midpoint of the Session, when all bills that are not exempt must pass their chamber of origin: February 20th.
 - First Adjournment/End of the Regular Session: March 28th.
 - Veto Session: April 10th through 12th.
- The Legislature convenes at 2:00 PM on Monday. The Governor presents her State of the State address Wednesday evening at 6:30 PM. The Governor's budget recommendation will be presented Thursday morning to a meeting of the House Appropriations and Senate Ways and Means Committees.
- There are 34 new lawmakers in the Kansas Legislature, meaning committees will likely spend some time educating new members on processes, current statutes, etc.
- Property tax relief remains the top priority for Republicans, as well as for some Democrats, though the Governor has hinted she is hesitant at further tax relief of any kind following last year's comprehensive sales and income tax relief bill passed during the Special Session. It is unclear exactly what proposals may advance, but a hearing on a constitutional amendment to cap valuations is already scheduled in Senate Tax the first week.
- The looming 2026 Gubernatorial race will impact policy debates for the next two years. So far, a handful of Republicans have announced interest, including Secretary of State Scott Schwab and former Lieutenant Governor Jeff Colyer. No one on the Democratic side has formally announced yet, but many are wondering if Lieutenant Governor Toland will forego opportunities in the private sector to run for Governor.
- As we have previously reported, the budget process this year will be notably different, and expedited. The Legislature, as is the case in a handful of other states, opted to assemble a legislature-initiated budget, rather than take direction

from a Governor's budget, which has almost always been the precedent and process in Kansas. We expect budget subcommittees to solicit public testimony much sooner than usual.
