Rules & Regulations

The following are the Official Rules for the **CBHBA Builders on the Bay Annual Fishing Tournament**. It is the contestants' responsibility to read, understand, and comply with all rules outlined below. Non-compliance will be grounds for disqualification from the tournament. By registering for and participating in the **CBHBA Builders on the Bay Annual Fishing Tournament**, each team and participant agrees to be bound by these Official Rules.

Please view the Payout Information sheet for entry regulations on each Main Pot and Side Pot.

1. Teams must be pre-registered to participate, and no registration will be allowed after the deadline unless extended in writing by tournament director. Entry forms must be received by the stated entry deadline to participate. Entry forms must be complete with all names and contact information. In the event of inclement weather, the tournament will be rescheduled. Registration will not be refunded.
2. This is a team tournament. Each team shall consist of no more than four anglers. A team entry can consist of one or two or three anglers' but will compete against all the other full teams. Teams may hire a guide if they so choose, but guide-caught fish cannot be entered in competition. All teams/boats must be registered by a CBHBA member. The member is not required to fish but must designate a Team Captain (Point of Contact) as an angler. All teams and individual kayak entries will be competing in the same division for the same categories. There will NOT be separate Guided/Non-Guided/Kayak Divisions. Kayak teams and teams that choose to wade fish must remain within eyesight of each other and vessel at all times throughout tournament hours.
3. Tournament goodie bags will be distributed at the mandatory Captain's Meeting & Social the night before the tournament, Friday, June 21st at 5PM. It is mandatory for Captain's to attend and all other participants are welcome to join as well!
4. Entrants must be present to win in the door prize giveaways.
5. Fishing is allowed only in Texas State waters. There are no bay boundary lines; however, the fishing area is restricted to the inshore waters of the bay and water to one nautical mile offshore of the beach and jetties.

6. Anglers may fish in any way they choose boat, wade, surf, pier, jetty, beachfront, kayak, etc. Fish must be caught on rod and reel with live, dead or artificial baits.
7. Tournament Fishing Times begin at 12:01 am (first cast/lines in the water) to 3pm, Saturday, June 22nd. No captain's meeting or check-in required on the day of to start fishing. Only fish caught during tournament fishing times may be entered in the competition. The fish weigh-in location is at Doc's Seafood and Steaks, under the JFK causeway on the Intercoastal Waterway on North Padre Island, Corpus Christi. Weigh-in will open at 1pm and close at 3pm. Weigh-in Master will call time at 3pm. Team Captain AND fish being weighed must be in line no later than 3PM. The Weigh-in Master will weigh each boat's fish in the order that the team checked in. Only the Team Captain or alternate will be allowed at the Weigh-in table.
8. All contestants are required to follow high standards of sportsmanship, courtesy, safety and conservation.
9. All state and federal laws must be observed. Fish must be of legal size according to Texas Parks & Wildlife Department regulations. No angler may retain a trout over 20". Calcutta Stringer will consist of 2 redfish and 1 trout. Team Heavy Redfish must be the same heaviest Redfish used in Calcutta stringer. Team Heavy Trout must be same Trout used in Calcutta stringer. Team spot pot DOES NOT have to be same Redfish from Calcutta. Team Sweet 17 Trout DOES NOT have to be same trout from Calcutta. Team heavy flounder shall be only 1 Flounder weighed in per team. No oversized/tagged redfish may be entered in the tournament, competition is only for slot redfish (red drum 20-28", ALL trout 15-20").

10. All contestants must have a valid fishing license and are required to obey all federal, state and local laws and regulations. All Parks and Wildlife Rules and Regulations will be enforced. Safe boating must be observed at all times. It is encouraged to wear personal floatation devices at all times.
11. The winning fish in weight categories will be the heaviest fish by weight in decimal pounds as determined by the tournament weighmaster. To help reduce the pressure on our fishery, you are encouraged to enter the SAME FISH in multiple categories (example heavy red must be the same red as stringer red). In the event of a tie by weight, the tie breaker will be decided by length. If still a tie, the earlier time of weigh in will be the tie breaker.

12. If there is no winner for any place in any prize category that prize money will go back to the CBHBA.
13. Only bring the fish to be weighed into the tournament to the Weighmaster. If a fish is kicked/disqualified/called dead by the Weighmaster it cannot be replaced with another fish in its place. Weighmaster will not select your fish for you. The fish you pick is the fish you enter. No scales or means of measuring will be available from weighmaster or tournament members prior to official weigh in.
14. The tournament weighmaster will be an experienced fish handler volunteering to measure and weigh fish. If, in his/her opinion, any fish entered in the tournament was caught outside Tournament Fishing Times or was caught by means other than rod and reel or was tampered with in order to alter weight or length, the team entering the fish in question is subject to disqualification at the discretion of the tournament director. All decisions by the weighmaster and tournament director are final.
15. All protests, objections, or suspicions of violations of Official Rules must be provided to the tournament director in writing no later than 3:30pm. Failure to provide timely written notification will be grounds for dismissal of the objection. A \$200 cash deposit must be submitted with your written protest no later than 3:30pm. If protest is upheld, cash deposit will be returned to team, if protest is not upheld, CBHBA will retain deposit.

By entering the CBHBA Fishing Tournament, we hereby waive all liability claims against all parties associated with said tournament. We agree to abide by all federal, state, and tournament rules and realize our immediate disqualification for infractions of tournament rules without refund. We also agree to abide by tournament official rulings.
