





Amplifying the Voice of FLCs

CFLCA and the Bravo Ag Group returned to Capitol Hill in April 2024, fostering relationships and shedding light on the critical role FLCs play in agriculture for our nation's lawmakers.

Participants met with legislative offices from across the nation to discuss pressing issues we are facing which threaten food and national security. Conversations focused on the burdens of rising costs; expanding regulatory requirements at the federal, state, and local levels; and the critical need to support a stabilized workforce. We fielded questions regarding the Farm Workforce Modernization Act and explained potential repercussions of mandatory E-Verify that would ripple through to our family dinner tables. With the Department of Labor we addressed the negative reputation that bad actors make for the industry and called for prioritizing enforcement to better protect workers and guide compliant employers.


