We will cover federal issues such as the EEOC's litigation priorities, how to plan for the next increase in the DOL's salary basis for exempt employees and how to approach the 80/20/30 rule for tipped employees. Colorado has been busy on the employment side as well. We will review Colorado's POWR Act which brought changes to the state discrimination and harassment laws and restricts severance and non-disclosure agreements, new pay transparency obligations, updates to the Healthy Families and Workplaces Act, the Job Application Fairness Act and the FAMLI Act. It's a lot, but this session will review the legal requirements so that a layperson can understand the obligations and provide practical guidance on getting and staying in compliance.

# 10:35 a.m. – Update on CHLA's Lawsuit Against Colorado & Denver's Building Performance Standards

In April, the CHLA Board of Directors made a landmark decision to align forces with the Colorado Apartment Association and the Colorado Chapter of the National Association of Industrial and Office Properties. Together, we have embarked on a legal challenge in federal district court against Regulation 28 and Energize Denver. We firmly believe that both Regulation 28 and Energize Denver are in violation of federal law, specifically the Energy Policy and Conservation Act (EPCA). These regulations impose undue burdens on our industry, hindering growth and creating massive financial challenges. Our lawsuit seeks to invalidate and set aside these regulations in their entirety.

During this session, our attorney in this matter, Paul Seby will provide an update on this important legal effort.
