**TO U.S. TOMATO PROCESSORS AND INTERESTED PARTIES:**

Listed below are the 2016-2017 Bulk Tomato Paste and Bulk Tomato “Paste for Sale” pack and inventory **estimates** as of March 1, 2017 for U.S. Tomato Processors. The 2016-2017 U. S. Processed Tomato Supply and Movement reported is based on an estimated 95.5% of the industry reporting data for bulk tomato paste. Representation below is assuming 100% reporting as well as actual paste industry aggregate reporting of an estimated 95.5%. All numbers are rounded to the nearest 1,000 lbs. for the purposes of this report.
