- 4) Just answer the question, nothing else
- 5) Answer based on your knowledge only

Recent OSHA Updates

- OSHA ETS –COVID Vaccine Requirement
 - November 5th (fully in place in January)
 - Challenged in Courts
 - 100+ employees (not subs)
 - Outdoor vs. Indoor Employees

Potential OSHA Regulatory Changes

- Heat Illness Prevention in Outdoor and Indoor Work Settings
- Amendments to the Cranes and Derricks in Construction Standard
- Update to the Hazard Communication Standard
- Lock-Out/Tag-Out Update
- Crystalline Silica; Revisions to Table 1 in the Standard for Construction
- Personal Protective Equipment in Construction
- Powered Industrial Trucks Design Standard Update
- Improve Tracking of Workplace Injuries and Illnesses
