


Standard Industrial Classification (SIC) codes are assigned by the U.S. government to categorize the industries to which companies belong.

- 5812: Eating place
- 5813: Drinking places (alcoholic beverages)
- 7011: Hotels and Motels
- 7032: Sporting and recreational camps
- 7041: Organization hotel & lodging houses, on membership basis






